

## Requests to use Wireless LAN Dongle

### ◇ Frequency band for use

The product uses the frequency band of 2.4 GHz band, and also other wireless equipment may use the same frequency. To prevent the radio wave interference with other wireless equipment, please use paying attention to the following terms.

#### Cautions to use Wireless LAN equipment

In the frequency band for use of this equipment, the in-plant radio stations for the mobile identification which is used on the manufacturing lines in factories (Radio station that needs the license), specified low power radio stations (Radio station that needs no license) and amateur radio stations (Radio station that needs the license) are operated in addition to the industrial/scientific/medical equipment like microwave ovens.

1. Check that the in-plant radio stations for the mobile identification, specified low power radio stations and amateur radio stations are not operated in the vicinity prior to use this equipment.
2. If the case of harmful radio wave interference occurred from this equipment to the in-plant radio stations for the mobile identification, immediately change the location or stop the use of electric wave and then contact to our company (Page E30) to have a talk about the action to the interference avoidance (e.g. the installation of partitions).
3. If you have any problem, for example; when the case of harmful radio wave interference occurred from this equipment to the in-plant radio stations for the mobile identification or the amateur radio stations, please contact to our company (Page E30).

## Requests to use Wireless LAN Dongle (continued)

### ◇ Equipment qualification

The product needs no license of radio stations because it has been approved for the certification of conformance to technical standards in accordance with the Radio Act. However, it is prohibited to implement the following acts to the product by the Radio Act.

- To disassemble or remodel,
- To erase the nameplate attached to the side of product.

### ◇ Usage restrictions

Please note that there are following restrictions to use the product.

When those restrictions are not complied, we deny any liability for the incidental loss and damage raised by the use of the product or the unusable product.

- Use the product as the wireless LAN equipment.
- The product can be used only in the operational countries listed on our website.
- The product is designed to be able to operate in the country where the legal regulation standard is different. Set the country code corresponding to the country to use the product because the specified country code has been set at manufacturing. Please set the code with great care because it will be the violation of law if you set the wrong country code.
- **Do not connect to the wireless network which you have no authority of utilization.**  
During automatic search in the wireless network circumstances, a wireless network (SSID\*) which you have no authority of utilization may be indicated. It may be deemed as an illegal access.

- **Do not use the product where magnetic field/static electrical charge/radio disturbance occurs.**

When you use the product near the following equipment, the communication may break up or the speed may be slow.

- Microwave oven
- Digital cordless telephone set
- Near the equipment that uses the electric wave of 2.4 GHz band.

Example; Equipment supporting Bluetooth, wireless audio apparatus or game machine.

Select the wireless broad band router (Access point) of 802.11 n (2.4 GHz). Use the encryption scheme of “AES.”

- **Transmitting and receiving data by electric wave may be intercepted.**
- **To reduce the security risk of the interception of communications or illegal access, set the password for the access point and PIN code to set for the driver so as to be complicated containing the alphanumeric characters.**
- **You are required to set the country code.**  
Please set with great care because it will be the violation of law if you set the wrong country code.

### Application

The product is the dedicated device to our servo driver.

(You cannot use it by connecting to PC.)

- For the servo driver you can connect with the product, terminals that can be connected by wireless, setup of the product and using method, check on our website;



## Name of parts

Wireless LAN Dongle



The lamp shows the state of product when it is connected to the servo driver.

### • Lights on:

The state when the power is supplied to the product but it is not communicating with the application. (Standby state)

### • Low speed blinking (Light off 1 sec. Light on 1 sec.):

The state when communicating with the application. (Communicating state)

### • High speed blinking (Light off 0.1 sec. Light on 0.1 sec.):


The state when the product failed to initialize and cannot communicate. (Error state)

### • Lights off:

The state when the power is not supplied to the product. (Non-energized state)

## Outline

This product is the wireless LAN dongle which enables the wireless connection between the servo driver and your terminals (PC, smartphones, tablet type terminals) by connecting to the servo driver. When you use the Windows OS applicable setup support software "PANATERM" or the iPhone terminals and Android terminals applicable setup support software "Panasonic Motor Setup App," it is required to connect your PC and servo driver with cables, but the wireless system will be possible by using this product.



By using this product and setup support software, primarily the following items will be realized in wireless communication.

- Edition of parameters for the servo driver
- Monitoring the operation and inner conditions
- Monitoring and clearing the alarm

## 1. Introduction (continued)

However, you cannot use the product in the wireless communication for the function to drive the motor, such as commissioning or frequency characteristics measurement.

Since the function which is available varies depending on the using application, refer to the instruction manual of each setup support software listed on the website for details.

The product cannot be connected to the Internet.

- iPhone is the trademark of Apple Inc. registered in the United States and other countries. The trademark of iPhone is used based on the license of Aiphone Co., Ltd.
- Android is the trademark or the registered trademark of Google Inc.
- Windows is the registered trademark or the trademark of Microsoft Corporation in the United States and other countries.
- You can download “PANATERM” applicable to Windows OS from our website.
- You can download “Panasonic Motor Setup App” applicable to iPhone terminals from App Store.
- For “Panasonic Motor Setup App” applicable to Android terminals, the smartphone version and tablet version are available. You can download either one from Google Play.

## 2. Connection mode

You can use the STA mode (Station mode) with the product.

### ● STA mode (Station mode)

This is the mode that this product operates as a station (Wireless LAN adapter) and communicates with the terminal via the equipment that operates as an access point (Wireless LAN access point). When you connect in this mode, please separately prepare the equipment which operates as an access point. In addition, change the network setting of the terminal and internal parameters in the driver so as to connect with the prepared access point.

In this mode, all the products in the same local area network can be selected from the terminal.



## 2. Connection mode (continued)


The access point to be prepared shall satisfy all the following specifications. If the following specifications are not satisfied, change the access point setting or prepare other access point.

- The wireless communication standard supports either IEEE 802.11n, g or b.
- The security protocol supports either WPA or WPA2.
- Use 2.4 GHz band as the frequency range (5 GHz band is prohibited to use).
- Communications between terminals located in the same local area is permitted.

For recommended access points, please check them on our website.


## 3. Connection

Connect the product to the connector X1 of the servo driver. When servo driver is connected by wireless for the first time, initial setup is necessary. Refer to “4. Setting” for details.



### Requests

Do not hook or place other wiring on the main body of product.





## 4. Setting

The servo driver has the parameter for setting the wireless LAN communications as the internal parameters. Before starting the wireless communications with the product, it is required to set (Initial setup) the parameters for wireless LAN communications by the use of USB communication. The following section shows the initial setup method. For the initial setup, you need to install the setup support software, and at the same time the terminal (i.e. Windows PC or Android terminal) that can use the USB communication and a USB mini-B cable is required.

### 1 Initial setup (Wired connection)

1. Connect the servo driver and terminal with the USB mini-B cable.

Use a USB mini-B type in the marketplace as the driver side connector. Select the terminal side connector to match to the specifications of the terminal.



2. Start up the setup support software to start the communications with the driver.
3. Set the following parameters on the “Wireless LAN/Driver Information Setting” screen of the setup support software and then write those parameters in EEPROM of driver.

\* To ensure the safety on the security, set the password and PIN code for the access point in the long and complicated character string as much as possible.

## 4. Setting (continued)

4. Turn off the power supply of driver.

The initial setup is now completed.

Next, establish the wireless system between the terminal and driver by using the product.




1. Turn on the power supply of access point.
2. Connect the product to the connector X1 of the driver.
3. Turn on the power supply of driver and check that the lamp of the product lights up.
4. Change the network setting of the terminal you want to use and connect to the target access point.
5. Use the terminal to start up the setup support software.
6. When the communication with the product has been succeeded, the nickname, part number and serial number of the corresponding driver will be displayed on the driver select screen.
7. When the driver is selected which is the target to connect, the entry of PIN code will be requested, and so enter the PIN code you set at the initial setup.
8. When the correct PIN code is input, the main screen of the setup support software will open.

Afterward, parameter setting or status monitoring can be carried out by wireless communications by using the setup support software.

For the method to use the setup support software, separately refer to the operating manual of each setup support software.

## 6. When you are in trouble

- Q. I connected the product to the driver and then turned on the power supply but the lamp of the product does not light up (Power is not supplied). Or the lamp immediately lights off.
- A. The servo driver may not support the product. For the supported servo drivers, please check them on our website.
- Q. The lamp of the product blinks at a high speed and the communication is impossible.
- A. The servo driver fails to read the parameters for setting wireless communications. Contact failure with the connector X1 may have occurred, therefore, reinsert the product and then turn on the power supply again. When the syndrome is not improved even if the above action was taken, the servo driver may not be supported in the system. Please check the supported servo drivers on our website.
- Q. The lamp of the product lights up, but the communication is impossible.
- A. Communication setting may be wrong. First of all, check the wireless LAN/driver parameter setting of the servo driver and check whether the SSID/password of the access point and parameter setting of the driver are matched, and whether the security protocol satisfies the setting of access point. Check if the same IP address as other equipment has been set when DHCP is set invalid and the IP address is set manually.

## 6. When you are in trouble (continued)

However, if the situation is not still improved, check whether the network setting of the terminal is set to connect to the target access point.

Also check that the access point is in accordance with the specifications for access point as described before.

- Q. Wireless communication breaks up during communications.
- A. The wireless communication circumstances may be in the interference. Check if the situation can be improved by the method to change the communication channel or eliminate the interference of communications after stopping the wireless communication of other equipment. Electric wave may be blocked off by obstacles. Since the metal has property difficult to transmit the electric wave in particular, the wireless communication may be impossible if the circumstances are covered by metal.

## Guarantee

### Guarantee period

- The guarantee period of the product shall be one year after your purchase or one year and six months after our manufacturing month.

### Guarantee description

- We will replace the product without charge when a failure occurred in the guarantee period in the normal use situation in accordance with this operation manual. However, the following cases shall be charged even if it is in the guarantee period.
  - (1) Failures caused by the wrong usage method and improper repair or remodeling.
  - (2) Failures caused by the fall after the purchase and damages during the transportation.
  - (3) Failures caused because the product is used beyond the scope of specifications.
  - (4) Failures caused by fire, earthquake, lightning strike, wind and flood, brine damage, abnormal voltage or other Acts of God and disasters.
  - (5) Failures caused by the intrusion of water, oil, metal fragments or other foreign matters.
- The scope of the guarantee shall be only for the delivered product unit. The damage induced by the failure of the delivered product shall be out of the scope.

# Precautions for use

- Cautions to export the product or the equipment installed with the product.

When the final user or the final application of the product is involved in the military affair or weapons, make sure to take the sufficient probation and required export procedures because the situation may be subject to the export control regulated by the “Foreign Exchange and Foreign Trade Control Law.”

- The product is manufactured only aiming at the use for general industrial products but not designed or manufactured for the purpose to be used with the equipment or the system involving human lives.
- The specialist who has the knowledge shall perform dealing with the product such as the installation, wiring, operation, maintenance and inspection.
- To apply to the facility where the occurrence of serious accident or damage is forecasted due to the failure of the product, make sure to install the safety device.
- If you conduct a study on the use of product in the special circumstances as for the nuclear energy control, aerospace instruments, transport facilities, medical equipment, various safety devices and equipment that demands the cleanness class, please contact us.
- We make our maximum effort to ensure the quality of the product, however, please take it into consideration to establish your fail safe design and ensure the safety in the operable range at the operation place because the product may generate unexpected actions caused by the loading of external noise or static electrical charge exceeding expectation or the possible failure of the input power source, wiring or parts.
- The wireless communications may break out and the function may not be accomplished normally due to the interference in the wireless communication circumstances or

the cause that the far distance between the product and access point or the access point and terminal, communication interception by obstacles such as the metal which blocks electric waves, failure of the terminal or access points. When the communication breaks out, please check the using wireless communication circumstances and the condition of using terminals and access points.

- Since this product uses radio wave and it may generate unexpected actions by the delay until the result is reflected actually on the movement of equipment when the setting change is carried out, please check there are no people around the site when the setting is changed and please take it into consideration to ensure the safety.
- Smoke of a cigarette may be generated depending on the content of failure of the product. Give consideration to it when the product is used in a clean room.
- When the product is used in the environment where the concentration of sulfur or sulfide-based gas (H<sub>2</sub>S, SO<sub>2</sub>, NO<sub>2</sub>, Cl<sub>2</sub> etc) is high, please take the conditions into account because the disconnection of chip resistor or bad contact of contacts by the sulfurization may occur.
- For the matching of structure, dimensions, lifespan, characteristics and laws and regulations with the installing equipment and parts, or the matching when the specification of installing equipment is changed, please make the final decision by the customer.
- We cannot guarantee the use beyond the scope of specifications of the product. Please use the product with great care.
- A part may be partially changed to improve the performance.
- Do not disassemble or remodel the product because it is prohibited by the Radio Act.
