


Mute / Un-mute

To mute the headset sound during a call press the Volume up and down button for 2 seconds and you hear 1 tone, which means the function has been activated. Upon activating the mute function, the person on the other side won't hear you, but you can hear all sound generated from the other side. To un-mute, press the Volume up and down button once.



To transfer a call from headset to the mobile phone press Volume down button for about three seconds, after hear 2 beeps, which means you have been successfully transferring the call. To transfer a call from mobile to headset, initiate it from the mobile phone. (For detail please refer to your mobile phone's user guide)



If you plug in USB dangle on your PC, laptop etc. you can use the BK-320 as a wireless microphone on MSN / Skype chatting.

Three-way call

Before use this function please make sure that you have subscribed threeway call service from your mobile

To start a three-way call by long pressing the Answering button for about three seconds until it beep twice when the third party is calling. To end the three way call long pressing the Answering button for about three seconds.

If you do not want to perform the three-way call immediately, you may keep the active call waiting and answer the waiting call by press the Answering button once, when you would like to start the three-way call follow the procedure above.

Connect with speaker base

While the headset plug into the speaker base, it could perform as a car kit / speakerphone. The function as follow

- To answer a incoming call press the answering button of headset
- To ending a call press the multi function button of the speaker Base.
- To power off by press and hold the multi function button about 5 seconds until the LED indicator turns red, the headset and the speaker base will turn off at the meantime.


