STEP 1:


 Cut the Drywall opening based on the following size table (**left**).

STEP 2:

 Form minimum 12GA support wire (**a**) (not included) to tie the DGA, Drywall Grid Adaptor.

 If necessary, use support wires to tie the additional holes of the DGA to reinforce the strength (**b**).

NOTE: Additional holes are Ø 0.19". DGA22-WHT includes 2 additional holes on each side. DGA14-WHT & DGA24-WHT includes 3 additional holes on each side.

 Or use the #8 self tapping screw to secure the DGA to structure (**c**). NOTE: #8 self tapping screw holes are Ø 0.13", 2 per side.
