

PEBBLE ONE (1) YEAR LIMITED WARRANTY

Pebble Technology Corp. ("Pebble") warrants this Pebble-branded hardware product against defects in materials and workmanship under normal use for a period of DNE (I) YEAR from the date of treat jurchase by the original end-user purchaser ("Warranty Period"). During this warranty period, if a defect arises, and you follow the instructions for returning the product, we will at our ordion, either (i) repair the product using either new or refurbished parts, (ii) replace the product with a new or refurbished product, or (iii) refund the purchase price of the product. Any replacement may be, at the option of Pebble, a new or remanufactured product.

A replacement product assumes the remaining warranty of the original product or ninety (90) days from the date of replacement or repair, whichever provides longer coverage for you.

When a product is exchanged, any replacement item becomes your property and the replaced item becomes Pebble's property. When a refund is given, the product for which the refund is provided must be returned to Pebble and becomes Pebble's property.

Exclusions and Limitations

This Limited Warranty applies only to hardware products manufactured by or for Pebble that can be identified by the "Pebble" trade name, or logo affixed to them.
