WALKIE TALKIES

If Walkie Talkies are not working, try resetting Walkie Talkies.

To Reset:

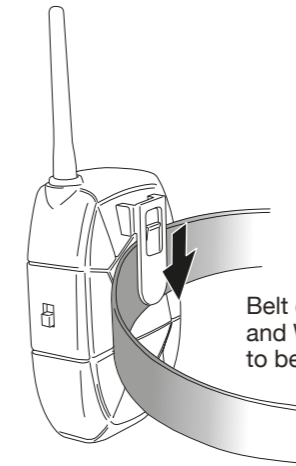
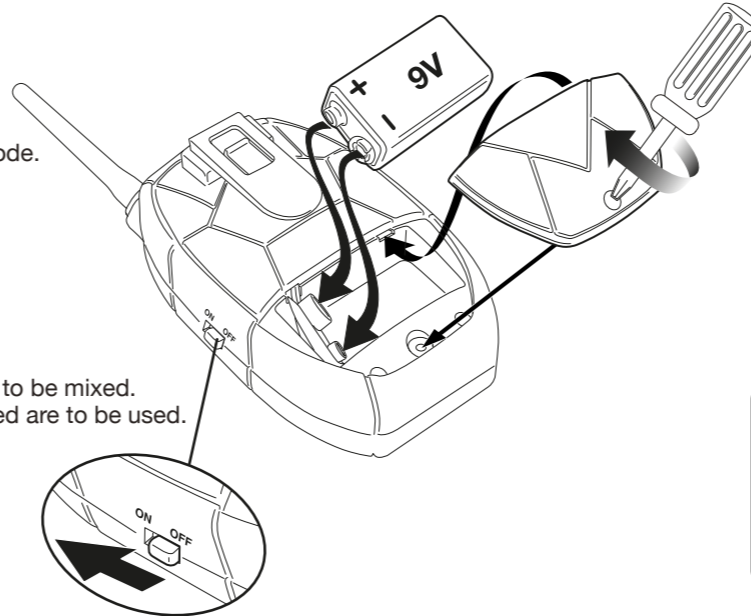
Slide the switch to "OFF", then slide the switch to the "ON" mode. If Walkie Talkies are still not working, try replacing the battery.

To change batteries:

- Unscrew battery cap.
- Take out old batteries and replace with 1 new 9V battery.
- Replace battery cap.

Battery Instructions:

- Non-rechargeable batteries are not to be recharged.
- Different types of batteries or new and used batteries are not to be mixed.
- Only batteries of the same or equivalent type as recommended are to be used.
- Batteries are to be inserted with the correct polarity.
- Exhausted batteries are to be removed from the toy.
- The supply terminals are not to be short-circuited.
- Batteries are to be removed from the toys when not in use.
- Batteries should only be replaced by an adult.
- Do not dispose of batteries in fire.
- Do not use rechargeable batteries.

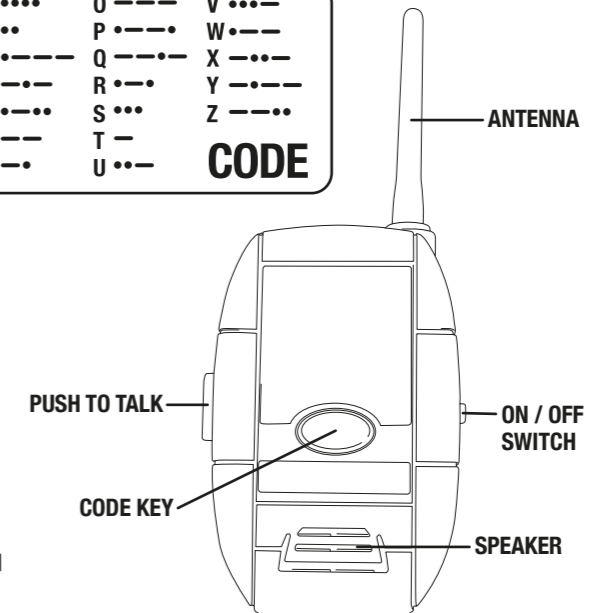

- Push side button (push to talk) and hold down and press code key to send code.
