






Bottom View




- 16. Battery/Memory card compartment

Step 1. Inserting the Battery

1. Unlock and open the battery/memory card compartment at the bottom of the camera.




- 2. Insert the battery into the compartment with the terminal facing inside the camera.
- 3. Close and lock the battery/memory card compartment





Step 2. Inserting an SD/SDHC/SDXC Memory Card

- 1. Unlock and open the Battery/memory card compartment at the bottom of the camera.
- 2. Insert the SD/SDHC/SDXC card into the memory card slot with the metallic part facing the back side of the camera.
- 3. Push the SD/SDHC/SDXC card into the memory slot until it clicks into place.
- 4. Close and lock the Battery/memory card compartment.



NOTE: To remove the SD/SDHC/SDXC card: Gently push the card until it pops out. Pull the card out and lock the battery cover.

Step 3. Setting the Language/Date/Time

- 1. Turn on the power by pressing **Power button**.
- 2. Use **4-way navigation control** to move and change the settings.
- 3. Press **OK button** to finish.





Step 4. Taking Images

- 1. Turn on the camera by pressing the **Power button**.
- 2. Compose your image in the LCD monitor.
- 3. Spin the **Zoom lever** to adjust view angle.
- Pressing Shutter button down halfway automatically focuses and adjusts the exposure, and pressing the Shutter button down fully captures the images.





When activating flashlight, the Flash won't pop up automatically. Please open the Flash manually by lifting the protruding grip on the Flash cover.

Step 5. Recording Videos





- 2. Focus your camera on the subject that you want to take.
- 3. Use the **Zoom lever** to zoom in and zoom out an image.
- To pause recording, press the key ▲.
- 5. To continue recording, press the key **\(\Lambda \)** again.
- 6. To stop recording, press the Movie button.



Step 6. Viewing images, videos and audio clips

- Press the Playback button on the camera.
 The LCD screen displays an image. Use the ◀ or ▶ keys to view previous/next image or video.
- 3. Press the **OK** button to play a video/audio clip.



Step 7. Using the Setup Menu

- to launch the Record/Playback 1. Press **Menu button** Menu.
- 2. Use the ◀ or ▶ keys to change the menu tab to **Setup**
- 3. Use the ∇ or \triangle keys to move through the menu selections.
- 4. Press the **OK** button to save and apply settings.
