



QMI Wireless HDMI Transmitter & Receiver Quick Setup

Before You Begin

With QMI Wireless HDMI Transmitter and Receiver, you can wirelessly stream high-definition multimedia content from your computer to your home entertainment center. Before setup, note the following configuration requirements:

- Your computer must have an available HDMI port and an available USB port.
- Your TV (or other external display) must have an available HDMI port.

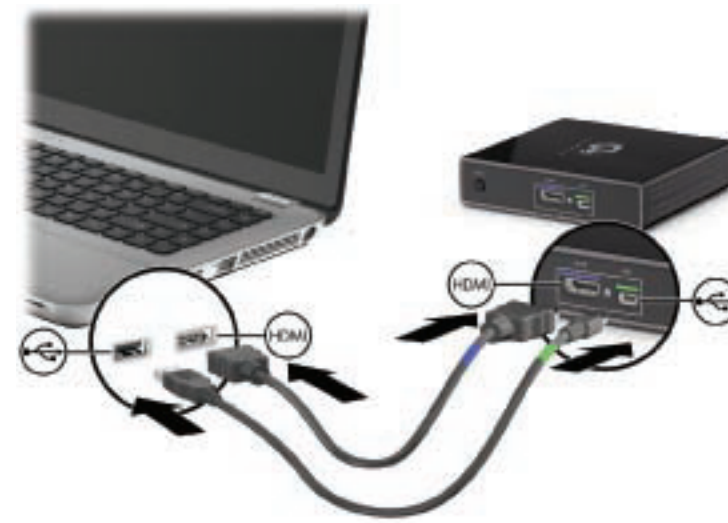
NOTE: If the HDMI port on your TV is occupied with another device, consider using an HDMI switch purchased separately from an electronics retailer.

- For optimal performance, locate the TV adapter no further than 5 m (16.4 ft) from the PC adapter.

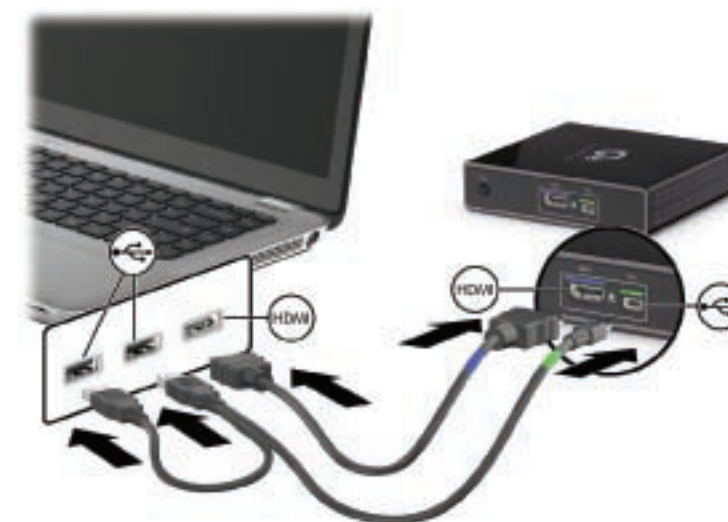
1 Connect the Transmitter to the computer.

NOTE: The location of the computer ports may vary.

NOTE: If the PC adapter light does not turn on after connecting with the USB cable, try connecting with the USB splitter cable instead.



OR



2 Connect the Receiver to your TV or other external display and to external power.



3 If you connected to a TV, press the input source button on the TV to select the HDMI input. When the components are connected correctly and the correct source is selected, the image on the computer display will be shown on the TV.

NOTE: If you are using an external display other than a TV, the display may not have an input source input button and the source may cycle automatically.

NOTE: It may take a few seconds for the adapters to link to each other and for the image on the computer to display on the TV (or other external display).


4 If desired, attach the PC adapter to the computer using the PC adapter clip and insert the Transmitter into the adapter stand.

NOTE: If desired, you can also insert the PC adapter into a stand instead of using the clip.




Components

Transmitter

- 
- Power light**
 - On: The adapter is on.
 - Off: The adapter is off.
 - Link light**
 - On: The adapter is linked to the TV adapter.
 - Blinking: The adapter is attempting to link to the TV adapter.
 - Power/upgrade port***: Connects the adapter to your computer.
 - HDMI port**: Connects the adapter to your computer.
 - Reset button***


*The reset button is only used during a software upgrade. The power/upgrade port is also used during a software upgrade.

Receiver

- 
- Power light**
 - On: The adapter is on.
 - Off: The adapter is off.
 - Link light**
 - On: The adapter is linked to the PC adapter.
 - Blinking: The adapter is attempting to link to the PC adapter.
 - Source button***
 - Upgrade port***
 - HDMI port**: Connects the adapter to your TV.
 - Power connector**: Connects the adapter to external power.
 - Menu button***

*The source button, upgrade port, and menu button can be used only during and after a software upgrade.

Cables

- 
- Power adapter and cable**: Connects the TV adapter to external power.
 - HDMI cables (2)**:
 - Short cable: Connects the PC adapter to your computer.
 - Long cable: Connects the TV adapter to your TV or other external display.
 - USB cable**: Connects the PC adapter to your computer.
 - USB splitter cable**: Connects the PC adapter to 2 USB ports on your computer when a single USB port does not provide enough power for the adapter.

Stands and Clip

- 
- Adapter stands (2)**: Use the stands to store the adapters in a vertical orientation.
 - PC adapter clip**: Use the clip to attach the PC adapter to your notebook PC display to save valuable desk space and provide enhanced mobility.

Regulatory and Safety Notices

Federal Communications Commission notice

Canada notices

This Class B digital apparatus meets all requirements of the Canadian Interference-Causing Equipment Regulations. Wireless operation is subject to 2 conditions. The first is that the wireless device may not cause interference. The second is that the wireless device must accept any interference, including interference that may cause undesired operation of the device.

CAUTION: When using IEEE 802.11a wireless LAN, this product is restricted to indoor use, due to its operation in the 5.15 to 5.25 GHz frequency range. Industry Canada requires this product to be used indoors for the frequency range of 5.15 GHz to 5.25 GHz to reduce the potential for harmful interference to co-channel mobile satellite systems. High-power radar is allocated as the primary user of the 5.25 to 5.35 GHz and 5.65 to 5.85 GHz bands. These radar stations can cause interference with and/or damage to this device.

High power radars are allocated as primary users (meaning they have priority) of 5250-5350 MHz and 5650-5850 MHz and these radars could cause interference and/or damage to IELAN devices. The antennas for this device are not replaceable. Any attempt at user access will damage your computer.

AC adapter notices

WARNING! To reduce the risk of electric shock or damage to the equipment:

- Plug the AC adapter into an AC outlet that is easily accessible.
- Disconnect power from the product by unplugging the AC adapter from the AC outlet (not by unplugging the AC adapter from the product).

Wireless Antennas

The wireless antennas transmit signals from the PC adapter to the TV adapter. These antennas are not visible from the outside of the adapters.



NOTE: For optimal transmission, keep the areas immediately around the antennas free from obstructions.

IMPORTANT NOTE:

FCC Radiation Exposure Statement: This equipment complies with FCC radiation exposure limits set forth for an uncontrolled environment.
