Installing wireless USB module driver

This *Quick Installation Guide* provides you with some basic instructions only. The following instructions will guide you through overall installation procedure. In OS-specific situations, you should follow the on-screen instructions to proceed.

Follow these steps below to install the wireless module driver.

Step 1: Close all Windows programs that are running.

Step 2:

Insert the module into a USB port of your computer, first. Then, a **Welcome to the Found New Hardware Wizard** window pops up.



Step 3:

Now, you may, for example, select **Yes**, this time only. Then, click **Next**.

As long as 3 conditions above are met, further transmitter test will not be required.
