
Governing law and Arbitration


This guide will show you how to use the Bluetooth Scale to make fishing more fun than it's ever been.

2. Powering Up

Download the iBobber app from the Android Play or iTunes App Stores.

This app is required to connect the software in the scale to your smart device.

Download on the App Store | GET IT ON Google Play

Step 1: Turn on Bluetooth antenna in your smart device settings.

Close out any prompt to connect via the phone's Bluetooth setting—you'll connect directly through the iBobber app.

***Note:** Some Android users may be forced to enter a code after trying to close the pop up window. If this happens, try standard codes such as 0000, 1111, 1234. Reach out by phone at info@reelsonar.com or 844-iBobber (messages only).

No need to go through your phone's settings or Bluetooth settings

Always connect to iBobber through our app.

- 1: On your smart device, turn on Bluetooth and open iBobber app.
- 2: Hold down power button to turn scale on before weighing fish. If scale—plus gripper if using—registers any weight, zero out using "tare" feature by clicking bottom button on scale.
- 3: Once on the hook/gripper, let go of fish as much as possible to allow scale to weigh properly.
- 4: When weight registers on digital display, hold down the bottom button (Tare/Bluetooth) for at least 2 seconds to send the weight to the iBobber app
- 5: Save your weight on the iBobber app
- 6: Share your catch on the netfish app or send to individuals via the various options found under "share"

Additional App Features

Weather

Tap either the weather icon on the Home Screen and you'll see: current temperature, daily high/low temps, precipitation %, wind speed & direction, barometric pressure, tides, moonphases, and sunrise & sunset times.

Trip Log

When you save your weight/length on iBobber, it is saved to your Trip Log. To see your catch's details, tap on a specific trip on the list and this will open your netfish™ account. There you will be able to edit your details and add more information such as photos.
