

Controls

- 1. LED indicator
- 2. Volume up (short press the button) / Next track (press and hold the button)
- 3. Multi-function button: Power ON/OFF. Play/Pause. Phone answer
- 4. Volume down (short press the button) / Previous track (press and hold the button)
- 5. Microphone
- 6. Charging port

LED Indicators

- Charging: Solid RED
- Fully charged: RED off and Solid BLUE light up
- Pairing Mode: Flashing BLUE/RED alternately
- Connected: Slow flashing BLUE (flash per 5 s)
- Playing/ Pause: Slow flashing BLUE (flash per 5 s)

Charging Earbud

Please charge the earbuds before use. Approximately 1 hours required for fully charged.

- o Plug the USB cable into the port on the speaker, plug the other end into the USB port on the computer or on the AC adapter with USB iack (DC 5V).
- Red LED will turn on to indicate that the unit is
- Red LED will turn off and Blue LED light up when fully
- Low battery: Voice prompt "low battery" when in low battery and with Red LED flash.

Start-up& Shutdown Functions

- Hold and press multi-function button (middle of buttons) to power ON the earbuds.
- Voice prompts "power on" and blue & red LED flashes alternately, waiting for pairing.
- Hold and press multi-function button is to shut down the earbuds.
- LED off if shutdown the earbuds.

Pairing Your Device

- Place the earbuds near the Bluetooth-enabled device.
- Press and hold multi-function button (middle of buttons) to power ON the earbuds, blue and red LED flashes alternately and voice prompts "pairing", the earbud is now in pairing mode. Follow the instructions of your device to search for the earbud.
- The earbud is called "MW-PCT-01" and choose the
- When your device is connected and the pairing is completed, the voice prompts"connected" and the LED indicator will turn to solid blue.
- Short press Volume +/- to adjust desired volume. Press and hold Volume +/- to skip to next track / previous track.

NOTE: The earbud is in the state of pairing the last device default in the first 3 seconds after starting. If failed to pair, the speaker will be in state of pairing automatically.

Receiving incoming call

If a Bluetooth enabled phone is connected wirelessly to the unit, you can receive calls and speak through the microphone on the units. When receive an incoming call, the voice prompt with incoming phone no. Press the multifunction button (middle of buttons) to answer the incoming call or hold the button to reject the call. Press multifunction button again to end call.
