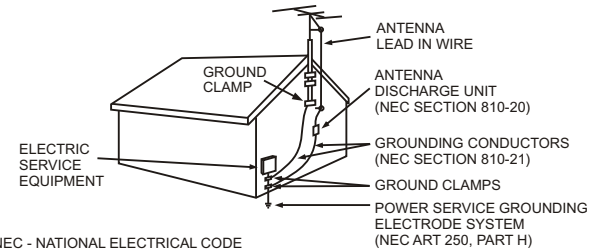
IMPORTANT SAFETY INSTRUCTIONS

1. **READ INSTRUCTIONS** - All the safety and operating instruction should be read before the product is operated.
2. **RETAIN INSTRUCTIONS** - The safety and operating instruction should be retained for future reference.
3. **HEED WARNINGS** - All warning on the product and in the operating instructions should be adhered to.
4. **FOLLOW INSTRUCTIONS** - All operating and use instructions should be followed.
5. **CLEANING** - Unplug this product from the wall outlet before cleaning. Do not use liquid cleaners or aerosol cleaners. Use a dry cloth for cleaning.
6. **ATTACHMENTS** - Do not use attachments not recommended by the product manufacturer as they may cause hazards.
7. **WATER AND MOISTURE** - Do not use this product near water- for example, near a bath tub, wash bowl, kitchen sink, or laundry tub, in a wet basement, or near a swimming pool, and the like.

13. **POWER-CORD PROTECTION** - Power supply cords should be routed so that they are not likely to be walked on or pinched by items placed upon or against them, paying particular attention to cords at plugs, convenience receptacles, and point where they exit from the product.
14. **PROTECTIVE ATTACHMENT PLUG** - The product is equipped with an attachment plug having overload protection. This is a safety feature. 15. **OUTDOOR ANTENNA GROUNDING** - If an outside antenna is connected to the receiver, be sure the antenna system is grounded so as to provide some protection against voltage surges and built-up static charges. 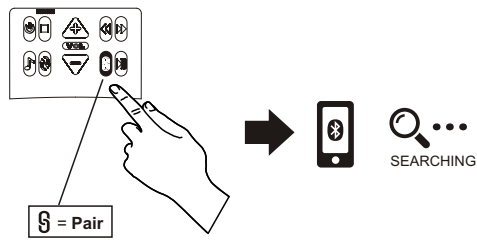
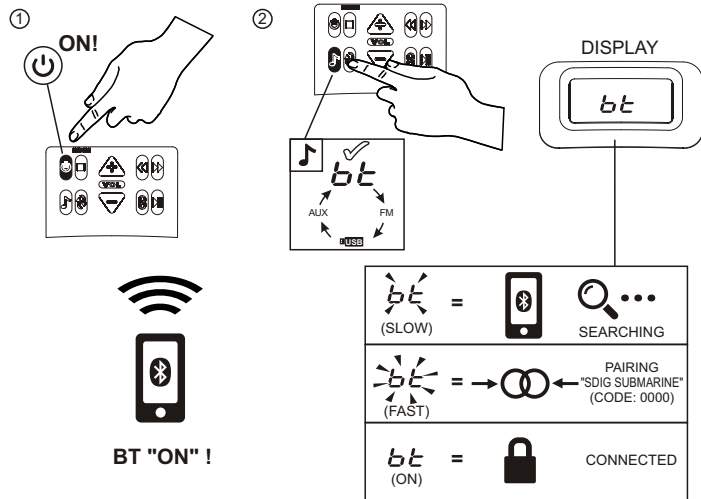


16. **LIGHTNING** - For added protection for this product during a lightning storm, or when it is left unattended and unused for long periods of time, unplug it from the wall outlet and disconnect the antenna or cable system. This will prevent damage to the product due to lightning and power-line surges.
17. **POWER LINES** - An outside antenna system should not be located in the vicinity of overhead power lines or other electric light or power circuits, or where it can fall into such power lines or circuits. When installing an outside antenna system, extreme care should be taken to keep from touching such power lines or circuits as contact with them might be fatal.
