## 1) Product Description

The 2AIHDMOD1 is a BLE module designed with the Nordic NRF52832 SoC and Skyworks SKY66112-11 FEM. It incorporates SPI, I2C, and GPIO interfaces for connecting peripherals and sensors



## 2) FCC Statement

### **Federal Communication Commission Interference Statement**
