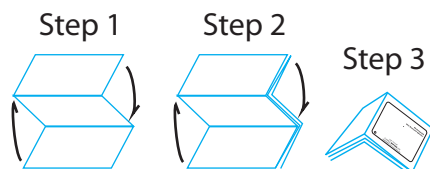

Consumer Product Safety Guide: IMPORTANT SAFETY INSTRUCTIONS

When used in the directed manner, this unit has been designed and manufactured to ensure your personal safety. However, improper use can result in potential electrical shock or fire hazards. Please read all safety and operating instructions carefully before installation and use, and keep these instructions handy for future reference. Take special note of all warnings listed in these instructions and on the unit.

1. **Water and Moisture** – DO NOT use near water. Keep away from wash basins, showers, sinks, etc.
2. **Ventilation** – The unit should be situated so that its location or position does not interfere with its proper ventilation. For example, it should not be situated on a bed, sofa, rug or similar surface that may block ventilation openings.
3. **Heat** – The unit should be situated away from heat sources such as radiators, heat registers, stoves or other appliances (including amplifiers) that produce heat.
4. **Power Sources** – The unit should be connected to a power supply only of the type described in the operating instructions or as marked on the appliance.

Introduction

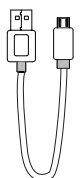
Thank you for purchasing the AL-M8. This product is designed to provide high quality wireless sound for your iPad, iPhone, iPod, computer, PDA or other Bluetooth audio device. This instruction booklet explains the basic operation and care of the unit. Please read them carefully and keep for future reference.

Maintenance

- Place the unit on a level surface away from sources of direct sunlight or excessive heat.
- Protect your furniture when placing your unit on a natural wood and lacquered finish. A cloth or other protective material should be placed between it and the furniture.
- Clean your unit with a soft cloth moistened only with mild soap and water. Stronger cleaning agents, such as benzene, thinner or similar materials can damage the surface of the unit.

Pairing Your Device

Pairing is the setup process to introduce your Bluetooth-capable device to the AL-M8. Once your device is paired, the AL-M8 can recognize it and you can play your audio through it.



1. Make sure your Bluetooth device is fully charged. Turn on your Bluetooth device and make it "discoverable" by turning on Bluetooth mode (check in Options or Settings).

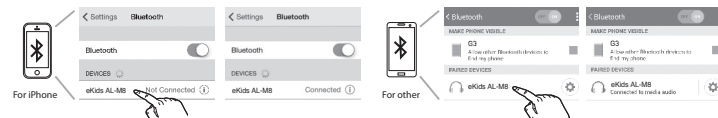


2. Slide the Power ON/OFF Switch to ON to turn on the AL-M8. The first time the unit is powered on, it will enter auto-pairing mode and attempt to connect to a Bluetooth device (if so, skip to step 4). Otherwise, follow step 3 to begin pairing.



3. Press and hold the **Bluetooth Pairing/ Speakerphone Button** for 3 seconds. The AL-M8 will beep and the Bluetooth status indicator light on top of the unit will flash quickly.

4. "eKids AL-M8" should appear in your device's Bluetooth menu. If "Not Paired", "Not Connected" or similar message appears, select "eKids AL-M8" to connect it. If prompted for a passcode, enter "1234" on your device's keypad.



5. If pairing is successful, a tone will sound and the Bluetooth indicator light will glow solid, indicating the AL-M8 is ready to play music. There should also be an indication on your device. If no device is successfully paired within 3 minutes the AL-M8 will default to previous mode. Once the AL-M8 is paired to a device, it will attempt to autolink when the device is within range (about 30 feet).

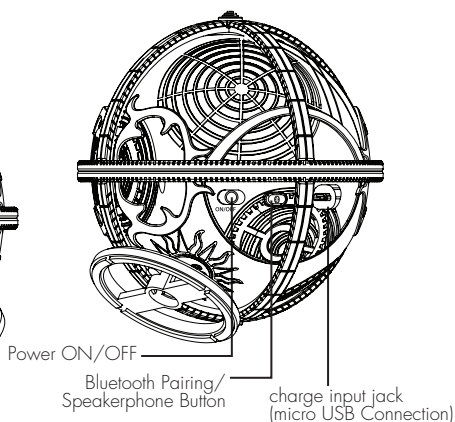
Front

When not in use, slide Power Switch to the OFF position to save battery power.

Pairing with a Different Device

When the speaker is ON, it will automatically link with the previously paired Bluetooth device as long as that device is still within range (approx. 30 feet). So to pair with a different device you must press and hold the **Bluetooth Pairing/ Speakerphone Button** for 3 seconds to re-enter pairing mode.

Playing Audio Via Bluetooth

- Move the ON/OFF Switch to the ON position to listen to audio streamed wirelessly from your paired iPad, iPhone, iPod or other Bluetooth device. The **Power/Charging/Pairing Indicator Light** on the unit will flash blue and a tone will sound as the unit searches for a previously paired device, and then turn solid blue once a previously paired device is detected.
- Use the controls on your device to play or pause audio, navigate tracks and control volume from your Bluetooth device.
- When done listening, move the ON/OFF Switch to the OFF position to turn the unit off.

Speakerphone Operation

NOTE: The unit must be powered on and linked to a Bluetooth phone to receive a call.

- When a call is received, playing music is muted to hear the ring tone. The **Power/Charging/Pairing Indicator Light** will flash quickly, then turn solid, then repeats the pattern until you answer the call. Press the **Speakerphone Button** to answer the call. For call waiting function, press the button again to answer the second call, and once more to return to the original call.
- When a call is completed, press the **Speakerphone Button** to end the call and resume previous function.

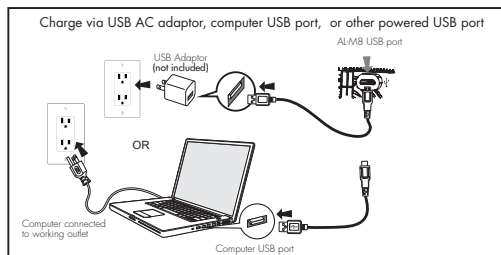

Using the AL-M8

Charging the Unit

CHARGE UNIT BEFORE USE

- Connect the micro USB plug to the micro USB charging port on the back of the unit.



NOTE: When the unit is on and not connected to a power source, the Power/Charging/Pairing Indicator Light flashing red means the battery needs charging.

- Connect the standard USB plug end of the cable to a power USB port on a computer or other USB charging device. For first time use, charge unit for about 5 hours.
- The **Power/Charging/Pairing Indicator Light** on the top of the unit glows red steadily while the unit is charging and turns OFF once the unit is fully charged. If unit is not powered on when micro USB plug is connected, the red light glows steadily to indicate unit is charging.

Using the AL-M8

Unit doesn't respond (no power)

- Make sure unit is completely charged.
- Check that all connections are correct and properly plugged in.
- Make sure your device is properly paired with the AL-M8.
- Make sure the ON/OFF Switch is not in the OFF position.
- The rechargeable battery in your speaker can be replaced only by eKids Consumer Repair Department.

Unit doesn't respond (locked up/ "frozen")

If the unit does not respond, try resetting the unit. Press and hold the **Bluetooth Pairing/ Speakerphone button** for 9 seconds. Note that doing so will clear settings, and any Bluetooth devices will need to be re-paired.

Trouble pairing device with AL-M8

Bluetooth implementation varies depending on your device's hardware and operating system. Please see our website for updates on pairing.

- When you power ON the speaker, it will automatically link with the last previously paired Bluetooth device if the device is still within range (approx. 30 feet). To pair with a different device you must turn off Bluetooth capability on the already paired device, or take it out of range.
- If your device does not auto-link when within range, re-pair the device. To do so, first delete the AL-M8 from your Bluetooth devices menu.
- Make sure your device is working properly. Check your device's manual for details on Bluetooth pairing and linking.
