## TIME SET/ALARM RESET

- Press and hold to set clock - Use +/- to select 12/24 hr display and press Time Set
- Use +/- to set hour and press Time Set to confirm

- Use +/- to set volume and press Sound Alarm to confirm settings


#### SLEEP MODE
