

## Charging the Mirror

• Lift the door on the back of the unit. Connect included USB charging cable to the USB port, and the other end to a powered USB port.




• The LED will flash red while charging, and will shut off automatically when the internal battery is fully charged.



## **Light Function**

• Tap the center button to turn the mirror light ON or OFF. (The light will activate if the speaker is ON or OFF.)



• Hold the center button to adjust the brightness level.

## **Audio Function**



• Press and hold power icon to turn speaker ON or OFF



• When mirror is ON, touch/hold icon for pairing mode, indicated by the blinking



- Select "iHome iCVBT1" on your device's Bluetooth menu to connect
- Tap to play / pause Bluetooth audio
- Tap to answer & end Bluetooth calls
- Touch/hold for 2 seconds to decline Bluetooth calls




Tap to lower or raise volume

Note: If no audio is playing for 15 minutes, the unit will automatically power off to conserve the battery.

# Adjusting the Mirror

The door on the back of the unit also works as a kickstand for the mirror. Adjust the door to the desired angle as needed.



## Reset

In the event of interrupted operation, use the extended wire of a paper clip or other thin tool to push in the Reset Button on the back of the unit.
