Audio Function



- Press power button to turn speaker On or Off
- When mirror is On, **press and hold** for pairing mode, indicated by the blinking **BLUE** LED
- Select "iHome iCVBT5" on your device's Bluetooth menu to connect

- Press to answer / end Bluetooth calls

 Press light button to turn ON Hi/Lo/OFF for the best light brightness




Light turns OFF after 25 minutes to save power.




Charging Devices

Other Devices

• Connect non-bluetooth devices with the included cable and AUX IN jack.



 AUX IN audio works when audio is paused on connected Bluetooth device.
