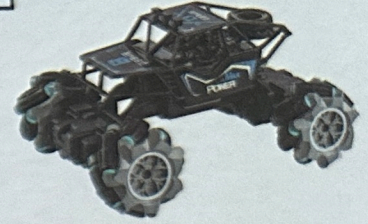
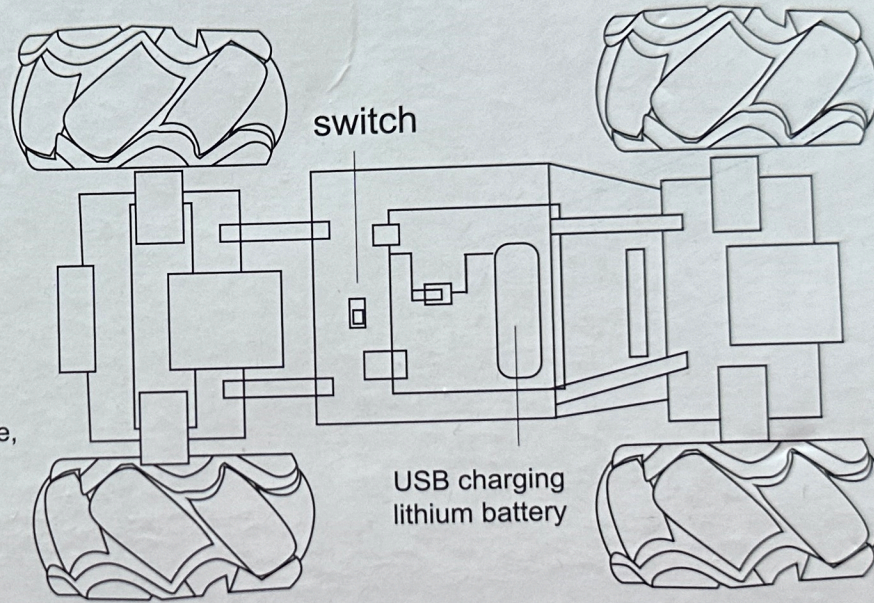
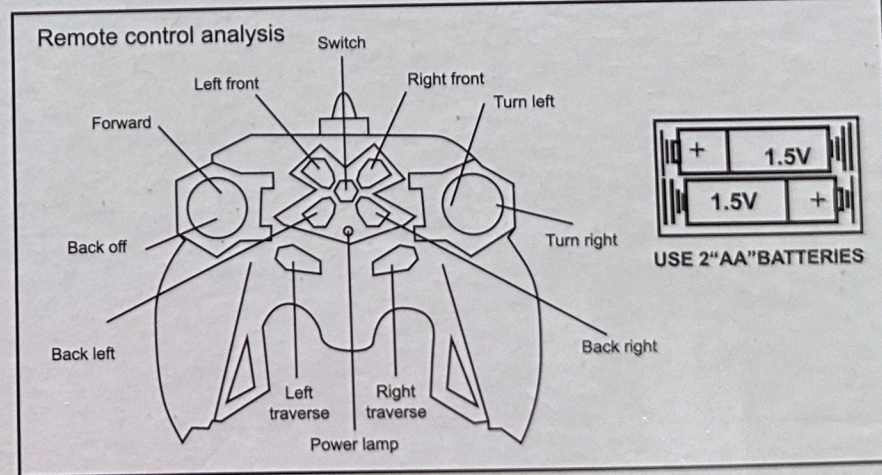


INSTRUCTIONS

- 1) The product uses a set of rechargeable power batteries
The remote controller uses 2 1.5V AA non-rechargeable batteries;
- 2) The battery shall be taken out and installed according to the polarity and voltage marks on the toy battery box. The battery shall not be short-circuited;
- 3) The non-rechargeable battery cannot be charged;
- 4) Rechargeable batteries must be charged under adult supervision;
- 5) The rechargeable battery shall be removed from the toy before charging;
- 6) Different types of batteries or new and old batteries cannot be mixed;
- 7) Only the same or equivalent battery as the recommended battery can be used;
- 8) The exhausted battery should be removed from the toy. If it is not used for a long time, please remove the battery from the toy;
- 9) The power terminal shall not be short-circuited;
- 10) Cannot connect to more than the recommended number of power supplies;
- 11) Regularly check whether the wires, plugs, shells and other parts are damaged.
If any damage is found, stop using them until they are repaired;
- 12) The model can only be charged using the UB line provided by the manufacturer;



1. The remote control car uses a set of rechargeable power battery pack (included in the package)
2. Turn off the body power, open the battery cover, take out the USB plug for charging
3. After charging, please put the USB plug back into the battery slot, and then carry out the remote control experience.
