# Step I

### **Install the Batteries**

- Open the battery compartment by pressing down the cover latch and sliding the door off the Presenter.
- 2. Insert the two supplied AAA batteries into the battery slots.
- 3. Make sure the positive (+) and negative (-) ends of the batteries match the polarity markings inside the battery compartment.
- 4. Slide the battery cover back and click into position.

# Step 2 Power On/Off Switch USB Receiver Storage Bay

### **Install the Receiver**

- Remove the USB receiver dongle from the built-in storage bay on the Presenter.
- Connect the USB receiver dongle to an available USB port on your computer. Wait for the computer to go through its default process of recognizing the new hardware and installing the built-in native driver.
- 3. Power on the Presenter by sliding the On/Off switch to the On position.
- 4. The Presenter and the receiver dongle come pre-paired at the factory. The Presenter should now be functioning normally.



### Re-Pairing the USB Receiver (if needed)

The Ruby Pro Presenter is paired with its USB Receiver Dongle prior to shipping. Should re-pairing becomes necessary, follow these simple steps:

- 1. With the USB Receiver dongle plugged into your computer, bring the remote control within 3 feet of the dongle.
- 2. Press the 'Connect' button on the underside of the remote.
- 3. The LED on the top of the remote will flash Green (indicating that pairing is in progress), and go dark when pairing is established.
- If pairing is unsuccessful, the LED will flash from Green to Red for approximately one mintue, and then go dark.

### Warranty
