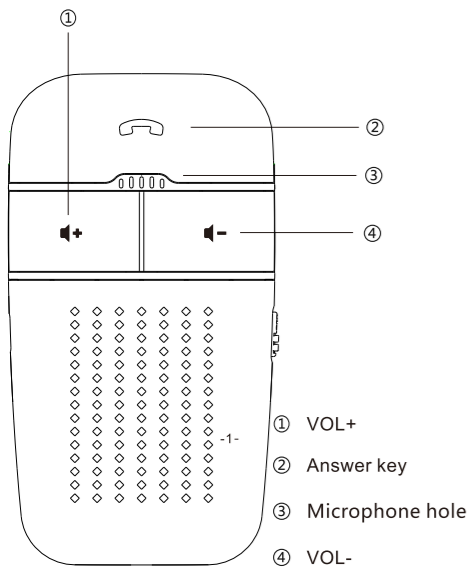
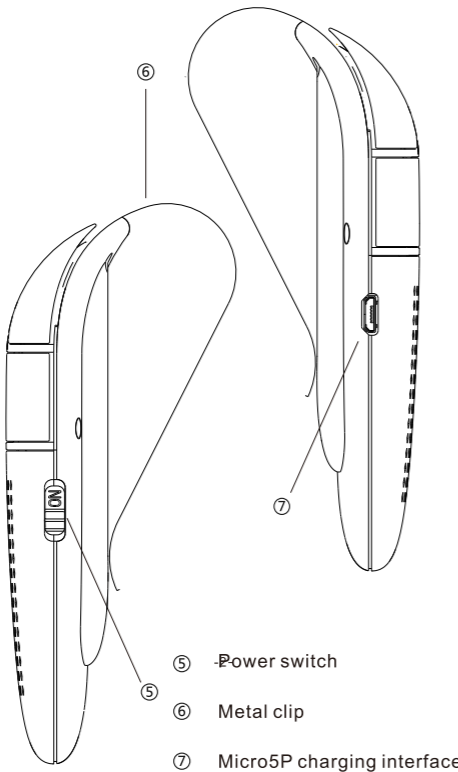


Key Schematic Diagram

Operation Guide

Tips

1. Before using this product for the first, please charge the battery for 4-6 hours to activate the battery completely.
2. To connect the Bluetooth, please turn on the Bluetooth of the mobile phone first, and then turn on the power of the Bluetooth phone.

Turning on

Turn the power switch to ON, and the device makes alert tone and connects automatically (detection time: 5sec)

Pairing prompt

After turning on, the answer key flashes red and blue alternatively, pairs with the mobile phone that has enabled Bluetooth in 150 seconds automatically, and makes alert tone after pairing successfully.

Pairing two mobile phones simultaneously

Turn on the first mobile phone and enter the pairing state, press and hold the Bluetooth key for 5 seconds after having paired to enter the pairing state again, and the first mobile phone will be disconnected; then, pair the second mobile phone, and then tap Connect on the first mobile phone, and the two mobile phones are paired simultaneously. **The passwords is:0000(if needed)**

Schedule off

In pairing state, if there is no mobile phone connected in 150 seconds, the device will turn off automatically (soft off) and make alert tone; the switch is in the OFF position at this moment.

In addition, if there is connection in 10 minutes after the mobile phone is disconnected from Bluetooth, the device will turn off automatically.

Restart vibrated

In the swith off stage, if you want to restart the device,you just need to shake anything nearby and it will work(shock like closing the door is available)

Answering/ending a call

When there is incoming call, the device makes ringtone alert, and you can press the Answer key to answer the call, and press the key again when the call ends.

Low battery alert

The red indicator flashes quickly for three times every 3 seconds, and the charging time is about 2 hours.

Charging indicator

Whether the switch key is in ON or OFF position, the red indicator is constantly lighted while charging, and is turned off after having charged.

Turning off

When the switch key is moved to OFF position, the device cuts off the power supply, turns off and doesn't make any alert tone.

Mobile voice navigation

When using the map navigation phone beep can be expanded via Bluetooth intercom voice navigation, long press the volume key for volume adjustment and subtraction, there is a beep.
