



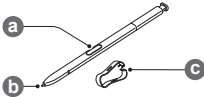

Using the S Pen

Use the S Pen to perform touch actions or draw on the screen of your mobile device. You can use additional features by pressing the S Pen button (**a**).

When you insert the S Pen into the S Pen slot of your mobile device, charging will start.
