## Drive safely at all times

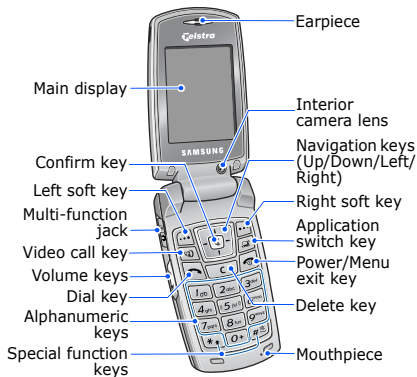

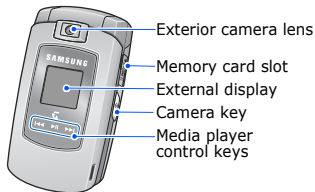

### Keys

In Menu mode, scroll through menu options.



In Idle mode, access the **My Place** menu.

In Menu mode, select the highlighted menu option or confirm input.



Make a video call.



Open the application switch window to access other applications without exiting the current application.



Make or answer a call.

In Idle mode, retrieve the numbers recently dialed, missed, or received.



Delete characters from the display or items in an application.



Press and hold to switch the phone on or off.

End a call.

In Menu mode, cancel input and return the phone to Idle mode.



Enter numbers, letters, and some special characters.

In Idle mode, press and hold [1] to access your voicemail server. Press and hold [0] to enter an international call prefix.



Enter special characters or perform special functions.



In Idle mode, press and hold [#] to activate or deactivate the Silent profile. Press and hold [\*] to enter a pause between numbers.



Adjust the phone volume.



In Idle mode, press and hold to turn on the camera.

In Camera mode, take a photo or record a video.



Return to the previous file during playback.



Press and hold to launch or close the media player.



Skip to the next file during playback.

2. Press the Navigation keys to move to the next or previous option.
3. Press **<Select>**, **<OK>**, or [ ] to confirm the function displayed or option highlighted.
4. Press **<Back>** to move up one level.  
Press [ ] to return to Idle mode.

### Use menu numbers

Press the number key corresponding to the option you want.

T9 mode	<p>To enter a word:</p> <ol style="list-style-type: none"><li>1. Press [2] to [9] to start entering a word.</li><li>2. Enter the whole word before editing or deleting characters.</li><li>3. When the word displays correctly, press [#] to insert a space. Otherwise, press [0] to display alternative word choices.</li></ol>
Number mode	<p>Press the keys corresponding to the digits you want.</p>



Symbol mode	Press the corresponding number key to select a symbol.

### Silent profile

You can activate the Silent profile to avoid disturbing other people. In Idle mode, press and hold [#].

### Phone lock

1. In Idle mode, press <Menu> and select **Settings** → **Security** → **Phone lock**.
2. Select **On**.
3. Enter a new 4- to 8-digit password and press <Confirm>.
4. Enter the new password again and press <Confirm>.

## Make or answer calls



### Make a call

#### To make a voice call:



1. In Idle mode, enter an area code and phone number.
2. Press [].  
Press [/>] to adjust the volume.
3. Press [] to end the call.

#### To make a video call:



1. In Idle mode, enter an area code and phone number.

2. Press [.
3. Press [] to end the call.

#### Answer a call

1. When the phone rings, press [].  
If it is a video call, press **<Show me>** to allow the caller to see you via the camera.
2. Press [] to end the call.

#### Use the speakerphone feature

During a voice call, press [] and then **<Yes>** to activate the speaker.  
Press [] again to switch back to the earpiece.





#### Make a multi-party call

1. During a call, call the second participant.  
The first call is put on hold.
2. Press **<Options>** and select **Join**.
3. Repeat step 1 and 2 to add more participants.
4. During a multi-party call:
  - Press **<Options>** and select **Split** to have a private conversation with one participant.
  - Press **<Options>** and select **End** → **Select participant** → the participant you want to drop → **Drop** to drop one participant.

- 
5. Press [] to end the multi-party call.

## Use the camera






### Take a photo

1. In Idle mode, press and hold [] to turn on the camera.
2. Aim the lens at the subject and make any desired adjustments.
3. Press [] or [] to take a photo. The photo is saved automatically.
4. Press <> to take another photo.

### View a photo

1. In Idle mode, press <**Menu**> and select **My files** → **Images** → **My photos**.
2. Select the photo you want.

### Record a video

1. In Idle mode, press and hold [] to turn on the camera.
2. Press [**1**] to switch to Record mode.
3. Press [] or [] to start recording.
4. Press [] or [] to stop recording. The video is saved automatically.
5. Press <**Back**> to record another video.

---

### View a video

1. In Idle mode, press **<Menu>** and select **My files** → **Videos** → **My video clips**.
2. Select the video you want.

## Play music

---


### Copy music files to the phone

Use these methods:



- Download from the wireless web.
- Download from a computer using the optional Samsung PC Studio. See Samsung PC Studio User's Guide.
- Receive via Bluetooth.
- Copy to a memory card and insert the card into the phone.

---

### Create a playlist


1. In Idle mode, press **<Menu>** and select **Media player**.
2. Scroll to the **Music** tab.
3. Press **<Options>** and select **Create playlist**.
4. Enter the name for the playlist and press **<Save>**.
5. Select the playlist you just created.
6. Press **<Options>** and select **Add** → **Playlist** or **Files**.
7. Scroll to the playlist you want, or press [  ] to select the files you want.
8. Press **<Select>** or **<Add>**.

### Play music files


1. Select the file you want to play.
2. During playback, use the following keys:
  - : pause or resume playback.
  - Left: return to the previous file. Move backward in a file when held down.
  - Right: skip to the next file. Move forward in a file when held down.
  - : adjust the volume.
3. Press [Down] to stop playback.

## Browse the web

### Launch the web browser

In Idle mode, press <  >. The homepage of your service provider opens.


### Navigate the web

- To scroll through browser items, press [Up] or [Down].
- To select an item, press [].
- To return to the previous page, press <**Back**>.
- To access browser options, press <**Options**>.

### Add a contact

1. In Idle mode, enter a phone number and press **<Options>**.
2. Select **Add to Phonebook** → **New** → a number type.

2. Enter the first few letters of the name you want.
3. Select a contact.

4. Scroll to a number and press [  ] to dial, or press [  ] and select **Edit** to edit contact information.

## Send messages

### Send a text message

1. In Idle mode, press **<Menu>** and select **Messages** → **Create message** → **Message**.
2. Enter the message text.
3. Move to the recipient field.
4. Enter destination numbers.
5. Press **<Options>** and select **Send** to send the message.



**Send a multimedia message**

1. In Idle mode, press <**Menu**> and select **Messages** → **Create message** → **Message**.
2. Enter your message.
3. Press <**Options**> and select **Add subject**.
4. Press <**OK**>.
5. Enter the message subject.
6. Press [Down] to move to the text field.
7. Press <**Options**> and select **Add attachment**.
8. Add a media file, contact, calendar item, or bookmark item.

9. Press [Up] until the recipient field highlights.
10. Enter destination numbers or email addresses.
11. Press <**Options**> and select **Send** to send the message.

**Send an email**

1. In Idle mode, press <**Menu**> and select **Messages** → **Create message** → **Email**.
2. Enter the email text.
3. Press <**Options**> and select **Add subject**.
4. Enter the email subject.
5. Press <**Options**> and select **Add attachment** or **Create item**.

- 
6. Add a media file, contact, calendar item, or bookmark item.
  7. Press [Up] until the recipient field highlights.
  8. Enter email addresses.
  9. Press <Options> and select **Send** to send the email.

## View messages

---

### View a text message

1. In Idle mode, press <Menu> and select **Messages** → **Inbox**.
2. Select a text message.

### View a multimedia message

- 
1. In Idle mode, press <Menu> and select **Messages** → **Inbox**.
  2. Select a multimedia message.

### View an email

- 
1. In Idle mode, press <Menu> and select **Messages** → **Email inbox**.
  2. Press <Options> and select **Download**.
  3. Select an email or a header.
  4. If you selected a header, press <Options> and select **Retrieve** to view the body of the email.

## Use Bluetooth

Your phone is equipped with Bluetooth technology, enabling you to connect the phone wirelessly to other Bluetooth devices and exchange data with them, talk hands-free, or control the phone remotely.

### Turn on Bluetooth

1. In Idle mode, press **<Menu>** and select **Settings** → **Network settings** → **Bluetooth** → **Activation** → **On**.
2. Select **My phone's visibility** → **On** to allow other devices to locate your phone.

### Search for and pair with a Bluetooth device

1. In Idle mode, press **<Menu>** and select **Settings** → **Network settings** → **Bluetooth** → **My devices** → **Search new device**.
2. Select a device.
3. Enter a Bluetooth PIN or the other device's Bluetooth PIN, if it has one, and press **<OK>**.  
When the owner of the other device enters the same code, pairing is complete.

### Send data

1. Access an application, such as **Phonebook**, **My files**, **Calendar**, **Memo**, or **Tasks**.

- 
2. Select an item.
  3. Press **<Options>** and select **Send Business card via** or **Send via** → **Bluetooth**.
  4. Search for and select a device.
  5. If necessary, enter the Bluetooth PIN and press **<OK>**.

---

#### Receive data


1. When a device attempts to access your phone, press **<Yes>** to permit the connection.
2. If necessary, press **<Yes>** to confirm that you are willing to receive.

## Switch applications

You can switch to other applications from a menu, without closing the menu screen you are using.

---

#### Switch to an application

1. While using a menu, press [].
2. Select an application.


---

#### Available applications

- **Call**: open the dialling screen.
- **Messages**: access the **Messages** menu.
- **BigPond**: launch the web browser.

---

#### Close all running applications

1. Press [].
2. Scroll to **End all?**.
3. Press **<Yes>**.

Enter URL	Enter a URL address and access the associated web page.
Bookmarks	Save URL addresses in order to quickly access web pages.
Saved pages	Access the list of pages you have saved while online.

Menu	Description
History	Access the list of pages you have accessed recently.
Advanced	Clear the cache. Delete cookies or set whether or not they are stored. Change the settings for the web browser and access version and copyright information about it.
Browser settings	Select a connection profile to be used for accessing the wireless web.

Menu	Description
BigPond	Access a range of mobile entertainment from the BigPond homepage, only available on Telstra's Next G network.
FOXTEL	Access the online TV service supported by your service provider.

Converter	Do conversions, such as length and temperature.
Timer	Set a period of time for the phone to count down.
Stopwatch	Measure elapsed time.
World clock	Set your local time zone and find out the current time in another part of the world.

Display settings → Cover display → Wallpaper	Change the image that is displayed on the external display.
Display settings → Cover display → Greeting message	Enter the greeting that is displayed on the external display.
Display settings → Cover display → LCD contrast	Adjust the brightness of the external display.

Menu	Description
Display settings → Light settings → LCD brightness	Adjust the brightness of the main display for varying lighting conditions.
Display settings → Light settings → Backlight time	Select the length of time the backlight or display stays on when the phone is not used.
Display settings → Light settings → Keypad light	Set how the phone controls the use of the keypad light.
Phone settings → Language	Select a language for the display text.
Phone settings → Shortcuts	Use the Navigation keys as shortcuts to access specific menus directly from Idle mode.

Menu	Description
Phone settings → Own number	Check your phone numbers or assign a name to each of the numbers.
Phone settings → Volume key function	Set how the phone reacts if you press and hold [▲/▼] when a call comes in.
Phone settings → Cover keypad lock	Lock the exposed keys to keep accidental presses from affecting your phone's operation when the phone is closed.
Call settings	Set options for call functions.
Security → Phone lock	Activate your phone password to protect your phone against unauthorised use.

Menu	Description
Security → SIM lock	Set the phone to work only with the current USIM/SIM card by assigning a SIM lock password.
Security → PIN lock	Activate your PIN to protect your USIM/SIM card against unauthorised use.
Security → Privacy lock	Lock access to messages, files, call logs, contacts, calendar, memo, or tasks.
Security → Fixed dialling mode	Set the phone to restrict calls to a limited set of phone numbers, if supported by your USIM/SIM card.

Security → Change phone password	Change the phone password.
Security → Change PIN code	Change the PIN.
Security → Change PIN2 code	Change the PIN2.
Security → Mobile tracker	Set the phone to send the preset tracking message to your family or friends when someone tries to use your phone with another USIM/SIM card.
Application settings	Customise the settings for using applications available on the phone.

Menu	Description
Network settings → Bluetooth	Connect the phone wirelessly to other Bluetooth devices.
Network settings → Network selection	Select the network to be used while roaming outside of your home area, or let the network be chosen automatically.
Network settings → Network mode	Select the network you use.
Network settings → Preferred networks	Add a new network to your preferred network list, if your USIM/SIM card supports it.

## *Health and safety information*

## **Precautions when using batteries**

---

Never use any charger or battery that is damaged in any way.

Use the battery only for its intended purpose.

If you use the phone near the network's base station, it uses less power; talk and standby time are greatly affected by the signal strength on the cellular network and the parameters set by the network operator.

Battery charging time depends on the remaining battery charge, the type of battery and the charger used. The battery can be charged and discharged hundreds of times, but it will gradually wear out. When the operation time



(talk time and standby time) is noticeably shorter than normal, it is time to buy a new battery.

If left unused, a fully charged battery will discharge itself over time.

Use only Samsung-approved batteries and recharge your battery only with Samsung-approved chargers. When a charger is not in use, disconnect it from the power source. Do not leave the battery connected to a charger for more than a week, since overcharging may shorten its life.

Extreme temperatures will affect the charging capacity of your battery: it may require cooling or warming first.

Do not leave the battery in hot or cold places, such as in a car in summer or winter conditions, as you will reduce the capacity and lifetime of the battery. Always try to keep the battery at room temperature. A phone with a hot or cold battery may temporarily not work, even when the battery is fully charged. Li-ion batteries are particularly affected by temperatures below 0 °C (32 °F).

Do not short-circuit the battery. Accidental short-circuiting can occur when a metallic object (coin, clip or pen) causes a direct connection between the + and – terminals of the battery (metal strips on the battery), for example when

you carry a spare battery in a pocket or bag. Short-circuiting the terminals may damage the battery or the object causing the short-circuiting.

Dispose of used batteries in accordance with local regulations. Always recycle. Do not dispose of batteries in a fire.

## **Road safety**

---

Your wireless phone gives you the powerful ability to communicate by voice, almost anywhere, anytime. But an important responsibility accompanies the benefits of wireless phones, one that every user must uphold.

When driving a car, driving is your first responsibility. When using your wireless phone behind the wheel of a car, practice good common sense and remember the following tips:

Get to know your wireless phone and its features, such as speed dial and redial. If available, these features help you to place your call without taking your attention off the road.

When available, use a hands-free device. If possible, add an extra layer of convenience and safety to your wireless

phone with one of the many hands-free accessories available today.

Position your wireless phone within easy reach. Be able to access your wireless phone without removing your eyes from the road. If you get an incoming call at an inconvenient time, let your voice mail answer it for you.

Let the person you are speaking with know you are driving; if necessary, suspend the call in heavy traffic or hazardous weather conditions. Rain, sleet, snow, ice, and even heavy traffic can be hazardous.

Do not take notes or look up phone numbers while driving. Jotting down a To Do list or flipping through your Address Book takes your attention away from your primary responsibility, driving safely.

Dial sensibly and assess the traffic; if possible, place calls when you are not moving or before pulling into traffic. Try to plan calls when your car will be stationary. If you need to make a call while moving, dial only a few numbers, check the road and your mirrors, then continue.

Do not engage in stressful or emotional conversations that may be distracting. Make the people with whom you are talking aware that you are driving and suspend

conversations that have the potential to divert your attention from the road.

Use your wireless phone to call for help. Dial the emergency number in the case of fire, traffic accident or medical emergencies. Remember, it is a free call on your wireless phone!

Use your wireless phone to help others in emergencies. If you see a car accident, crime in progress or other serious emergency where lives are in danger, call the emergency number, as you would want others to do for you.

If you see a broken-down vehicle posing no serious hazard, a broken traffic signal, a minor traffic accident where no one appears injured, or a vehicle you know to be stolen, call roadside assistance or any other special non-emergency wireless number.

## **Operating environment**

---

Remember to follow any special regulations in force in any area and always switch off your phone whenever it is forbidden to use it, or when it may cause interference or danger.

When connecting the phone or any accessory to another device, read its user's guide for detailed safety instructions. Do not connect incompatible products.

As with other mobile radio transmitting equipment, users are advised that for the satisfactory operation of the equipment and for the safety of personnel, it is recommended that the equipment should only be used in the normal operating position (held to your ear with the antenna pointing over your shoulder).

### **Electronic devices**

---

Most modern electronic equipment is shielded from radio frequency (RF) signals. However, certain electronic equipment may not be shielded against the RF signals from your wireless phone. Consult the manufacturer to discuss alternatives.

#### **Pacemakers**

Pacemaker manufacturers recommend that a minimum distance of 15 cm (6 inches) be maintained between a wireless phone and a pacemaker to avoid potential interference with the pacemaker. These recommendations

are consistent with the independent research and recommendations of Wireless Technology Research.

Persons with pacemakers:

should always keep the phone more than 15 cm (6 inches) from their pacemaker when the phone is switched on.

should not carry the phone in a breast pocket.

should use the ear opposite the pacemaker to minimize potential interference.

If you have any reason to suspect that interference is taking place, switch off your phone immediately.

#### **Hearing aids**

Some digital wireless phones may interfere with some hearing aids. In the event of such interference, you may wish to consult your hearing aid manufacturer to discuss alternatives.

#### **Other medical devices**

If you use any other personal medical devices, consult the manufacturer of your device to determine if it is adequately shielded from external RF energy. Your physician may be able to assist you in obtaining this

information. Switch off your phone in health care facilities when any regulations posted in these areas instruct you to do so. Hospitals or health care facilities may be using equipment that could be sensitive to external RF energy.

## **Vehicles**

RF signals may affect improperly installed or inadequately shielded electronic systems in motor vehicles. Check with the manufacturer or its representative regarding your vehicle. ## **Posted facilities**

Wireless telecommunications is keeping us in touch, simplifying our lives, protecting us in emergencies and providing opportunities to help others in need. When it comes to the use of wireless phones, safety is your most important call.

## Wireless phone “Safety Tips”

Below are safety tips to follow while driving and using a wireless phone which should be easy to remember:

Get to know your wireless phone and its features such as speed dial and redial. Carefully read your instruction manual and learn to take advantage of valuable features most phones offer, including automatic redial and memory. Also, work to memorize the phone keypad so you can use the speed dial function without taking your attention off the road.

When available, use a hands free device. A number of hands free wireless phone accessories are readily available today. Whether you choose an installed mounted device for your wireless phone or a speaker phone accessory, take advantage of these devices if available to you.

Position your wireless phone within easy reach. Make sure you place your wireless phone within easy reach and where you can grab it without removing your eyes from the road. If you get an incoming call at an inconvenient time, if possible, let your voice mail answer it for you.

Suspend conversations during hazardous driving conditions or situations. Let the person you are speaking

with know you are driving; if necessary, suspend the call in heavy traffic or hazardous weather conditions. Rain, sleet, snow and ice can be hazardous, but so is heavy traffic. As a driver, your first responsibility is to pay attention to the road.

Do not take notes or look up phone numbers while driving. If you are reading an address book or business card, or writing a “to do” list while driving a car, you are not watching where you are going. It’s common sense. Don’t get caught in a dangerous situation because you are reading or writing and not paying attention to the road or nearby vehicles.

Dial sensibly and assess the traffic; if possible, place calls when you are not moving or before pulling into traffic. Try to plan your calls before you begin your trip or attempt to coincide your calls with times you may be stopped at a stop sign, red light or otherwise stationary. But if you need to dial while driving, follow this simple tip-dial only a few numbers, check the road and your mirrors, then continue.

Do not engage in stressful or emotional conversations that may be distracting. Stressful or emotional conversations and driving do not mix-they are distracting and even dangerous when you are behind the wheel of a car. Make

people you are talking with aware you are driving and if necessary, suspend conversations which have the potential to divert your attention from the road.

Use your wireless phone to call for help. Your wireless phone is one of the greatest tools you can own to protect yourself and your family in dangerous situations-with your phone at your side, help is only three numbers away. Dial 9-1-1 or other local emergency number in the case of fire, traffic accident, road hazard or medical emergency. Remember, it is a free call on your wireless phone!

Use your wireless phone to help others in emergencies. Your wireless phone provides you a perfect opportunity to be a "Good Samaritan" in your community. If you see an auto accident, crime in progress or other serious emergency where lives are in danger, call 9-1-1 or other local emergency number, as you would want others to do for you.

Call roadside assistance or a special wireless non emergency assistance number when necessary. Certain situations you encounter while driving may require attention, but are not urgent enough to merit a call for emergency services. But you still can use your wireless phone to lend a hand. If you see a broken-down vehicle posing no serious hazard, a broken traffic signal, a minor

traffic accident where no one appears injured or a vehicle you know to be stolen, call roadside assistance or other special non-emergency wireless number.

## Appendix C: consumer update on wireless phones

U.S. Food and Drug Administration

What kinds of phones are the subject of this update?

The term wireless phone refers here to hand-held wireless phones with built-in antennas, often called cell, mobile, or PCS phones. These types of wireless phones can expose the user to measurable radio frequency energy (RF) because of the short distance between the phone and the user's head. These RF exposures are limited by Federal Communications Commission safety guidelines that were developed with the advice of FDA and other federal health and safety agencies. When the phone is located at greater distances from the user, the exposure to RF is drastically lower because a person's RF exposure decreases rapidly with increasing distance from the source. The so-called "cordless phones," which have a base unit connected to the telephone wiring in a house, typically operate at far lower power levels, and thus produce RF exposures well within the FCC's compliance limits.

Do wireless phones pose a health hazard?

The available scientific evidence does not show that any health problems are associated with using wireless

phones. There is no proof, however, that wireless phones are absolutely safe. Wireless phones emit low levels of radio frequency energy (RF) in the microwave range while being used. They also emit very low levels of RF when in the stand-by mode. Whereas high levels of RF can produce health effects (by heating tissue), exposure to low level RF that does not produce heating effects causes no known adverse health effects. Many studies of low level RF exposures have not found any biological effects. Some studies have suggested that some biological effects may occur, but such findings have not been confirmed by additional research. In some cases, other researchers have had difficulty in reproducing those studies, or in determining the reasons for inconsistent results.

What is FDA's role concerning the safety of wireless phones?

Under the law, FDA does not review the safety of radiation emitting consumer products such as wireless phones before they can be sold, as it does with new drugs or medical devices. However, the agency has authority to take action if wireless phones are shown to emit radio frequency energy (RF) at a level that is hazardous to the user. In such a case, FDA could require the manufacturers of wireless phones to notify users of the health hazard and

to repair, replace or recall the phones so that the hazard no longer exists.

Although the existing scientific data do not justify FDA regulatory actions, FDA has urged the wireless phone industry to take a number of steps, including the following:

Support needed research into possible biological effects of RF of the type emitted by wireless phones;

Design wireless phones in a way that minimizes any RF exposure to the user that is not necessary for device function; and

Cooperate in providing users of wireless phones with the best possible information on possible effects of wireless phone use on human health

FDA belongs to an interagency working group of the federal agencies that have responsibility for different aspects of RF safety to ensure coordinated efforts at the federal level. The following agencies belong to this working group:

National Institute for Occupational Safety and Health  
Environmental Protection Agency Federal Communications Commission

Occupational Safety and Health Administration  
National Telecommunications and Information Administration

The National Institutes of Health participates in some interagency working group activities, as well.

FDA shares regulatory responsibilities for wireless phones with the Federal Communications Commission (FCC). All phones that are sold in the United States must comply with FCC safety guidelines that limit RF exposure. FCC relies on FDA and other health agencies for safety questions about wireless phones.

FCC also regulates the base stations that the wireless phone networks rely upon. While these base stations operate at higher power than do the wireless phones themselves, the RF exposures that people get from these base stations are typically thousands of times lower than those they can get from wireless phones. Base stations are thus not the primary subject of the safety questions discussed in this document.

What is FDA doing to find out more about the possible health effects of wireless phone RF?

FDA is working with the U.S. National Toxicology Program and with groups of investigators around the world to ensure that high priority animal studies are conducted to address important questions about the effects of exposure to radio frequency energy (RF).

FDA has been a leading participant in the World Health Organization International Electromagnetic Fields (EMF) Project since its inception in 1996. An influential result of this work has been the development of a detailed agenda of research needs that has driven the establishment of new research programs around the world. The Project has also helped develop a series of public information documents on EMF issues.

FDA and the Cellular Telecommunications & Internet Association (CTIA) have a formal Cooperative Research and Development Agreement (CRADA) to do research on wireless phone safety. FDA provides the scientific oversight, obtaining input from experts in government, industry, and academic organizations. CTIA-funded research is conducted through contracts to independent investigators. The initial research will include both laboratory studies and studies of wireless phone users. The CRADA will also include a broad assessment of

additional research needs in the context of the latest research developments around the world.

What steps can I take to reduce my exposure to radio frequency energy from my wireless phone?

If there is a risk from these products—and at this point we do not know that there is—it is probably very small. But if you are concerned about avoiding even potential risks, you can take a few simple steps to minimize your exposure to radio frequency energy (RF). Since time is a key factor in how much exposure a person receives, reducing the amount of time spent using a wireless phone will reduce RF exposure.

If you must conduct extended conversations by wireless phone every day, you could place more distance between your body and the source of the RF, since the exposure level drops off dramatically with distance. For example, you could use a headset and carry the wireless phone away from your body or use a wireless phone connected to a remote antenna

Again, the scientific data do not demonstrate that wireless phones are harmful. But if you are concerned about the RF exposure from these products, you can use measures like



those described above to reduce your RF exposure from wireless phone use.

What about children using wireless phones?

The scientific evidence does not show a danger to users of wireless phones, including children and teenagers. If you want to take steps to lower exposure to radio frequency energy (RF), the measures described above would apply to children and teenagers using wireless phones. Reducing the time of wireless phone use and increasing the distance between the user and the RF source will reduce RF exposure.

Some groups sponsored by other national governments have advised that children be discouraged from using wireless phones at all. For example, the government in the United Kingdom distributed leaflets containing such a recommendation in December 2000. They noted that no evidence exists that using a wireless phone causes brain tumors or other ill effects. Their recommendation to limit wireless phone use by children was strictly precautionary; it was not based on scientific evidence that any health hazard exists.

Do hands-free kits for wireless phones reduce risks from exposure to RF emissions?

Since there are no known risks from exposure to RF emissions from wireless phones, there is no reason to believe that hands-free kits reduce risks. Hands-free kits can be used with wireless phones for convenience and comfort. These systems reduce the absorption of RF energy in the head because the phone, which is the source of the RF emissions, will not be placed against the head. On the other hand, if the phone is mounted against the waist or other part of the body during use, then that part of the body will absorb more RF energy. Wireless phones marketed in the U.S. are required to meet safety requirements regardless of whether they are used against the head or against the body. Either configuration should result in compliance with the safety limit.

Do wireless phone accessories that claim to shield the head from RF radiation work?

Since there are no known risks from exposure to RF emissions from wireless phones, there is no reason to believe that accessories that claim to shield the head from those emissions reduce risks. Some products that claim to shield the user from RF absorption use special phone cases, while others involve nothing more than a metallic accessory attached to the phone. Studies have shown that these products generally do not work as advertised. Unlike

“hand-free” kits, these so-called “shields” may interfere with proper operation of the phone. The phone may be forced to boost its power to compensate, leading to an increase in RF absorption. In February 2002, the Federal Trade Commission (FTC) charged two companies that sold devices that claimed to protect wireless phone users from radiation with making false and unsubstantiated claims. According to FTC, these defendants lacked a reasonable basis to substantiate their claim.

What about wireless phone interference with medical equipment?

Radio frequency energy (RF) from wireless phones can interact with some electronic devices. For this reason, FDA helped develop a detailed test method to measure electromagnetic interference (EMI) of implanted cardiac pacemakers and defibrillators from wireless telephones. This test method is now part of a standard sponsored by the Association for the Advancement of Medical Instrumentation (AAMI). The final draft, a joint effort by FDA, medical device manufacturers, and many other groups, was completed in late 2000. This standard will allow manufacturers to ensure that cardiac pacemakers and defibrillators are safe from wireless phone EMI.

FDA has tested hearing aids for interference from handheld wireless phones and helped develop a voluntary standard sponsored by the Institute of Electrical and Electronic Engineers (IEEE). This standard specifies test methods and performance requirements for hearing aids and wireless phones so that no interference occurs when a person uses a compatible phone and a compatible hearing aid at the same time. This standard was approved by the IEEE in 2000.

FDA continues to monitor the use of wireless phones for possible interactions with other medical devices. Should harmful interference be found to occur, FDA will conduct testing to assess the interference and work to resolve the problem.

What are the results of the research done already?

The research done thus far has produced conflicting results, and many studies have suffered from flaws in their research methods. Animal experiments investigating the effects of radio frequency energy (RF) exposures characteristic of wireless phones have yielded conflicting results that often cannot be repeated in other laboratories. A few animal studies, however, have suggested that low levels of RF could accelerate the development of cancer in laboratory animals. However, many of the studies that

showed increased tumor development used animals that had been genetically engineered or treated with cancer causing chemicals so as to be pre-disposed to develop cancer in the absence of RF exposure. Other studies exposed the animals to RF for up to 22 hours per day. These conditions are not similar to the conditions under which people use wireless phones, so we don't know with certainty what the results of such studies mean for human health.

Three large epidemiology studies have been published since December 2000. Between them, the studies investigated any possible association between the use of wireless phones and primary brain cancer, glioma, meningioma, or acoustic neuroma, tumors of the brain or salivary gland, leukemia, or other cancers. None of the studies demonstrated the existence of any harmful health effects from wireless phone RF exposures. However, none of the studies can answer questions about long-term exposures, since the average period of phone use in these studies was around three years.

What research is needed to decide whether RF exposure from wireless phones poses a health risk?

A combination of laboratory studies and epidemiological studies of people actually using wireless phones would provide some of the data that are needed. Lifetime animal exposure studies could be completed in a few years. However, very large numbers of animals would be needed to provide reliable proof of a cancer promoting effect if one exists. Epidemiological studies can provide data that is directly applicable to human populations, but 10 or more years follow-up may be needed to provide answers about some health effects, such as cancer. This is because the interval between the time of exposure to a cancer-causing agent and the time tumors develop - if they do - may be many, many years. The interpretation of epidemiological studies is hampered by difficulties in measuring actual RF exposure during day-to-day use of wireless phones. Many factors affect this measurement, such as the angle at which the phone is held, or which model of phone is used.

Batteries 1 Year

Leather Case/Pouch 90 Days

Other Phone Accessories 1 Year

**What is Not Covered?** This Limited Warranty is conditioned upon proper use of Product by Purchaser. This Limited Warranty does not cover: (a) defects or damage resulting from accident, misuse, abuse, neglect, unusual physical, electrical or electromechanical stress, or modification of any part of Product, including antenna, or cosmetic damage; (b) equipment that has the serial number removed or made illegible; (c) any plastic surfaces or other

externally exposed parts that are scratched or damaged due to normal use; (d) malfunctions resulting from the use of Product in conjunction with accessories, products, or ancillary/peripheral equipment not furnished or approved by SAMSUNG; (e) defects or damage from improper testing, operation, maintenance, installation, or adjustment; (f) installation, maintenance, and service of Product, or (g) Product used or purchased outside the United States or Canada.

This Limited Warranty covers batteries only if battery capacity falls below 80% of rated capacity or the battery leaks, and this Limited Warranty does not cover any battery if (i) the battery has been charged by a battery charger not specified or approved by SAMSUNG for charging the battery, (ii) any of the seals on the battery are broken or show evidence of tampering, or (iii) the battery has been used in equipment other than the SAMSUNG phone for which it is specified.

To obtain service under this Limited Warranty, Purchaser must return Product to an authorized phone service facility in an adequate container for shipping, accompanied by Purchaser's sales receipt or comparable substitute proof of sale showing the date of purchase, the serial number of Product and the sellers' name and address. To obtain assistance on where to deliver the Product, call Samsung Customer Care at 1-888-987-4357. Upon receipt, SAMSUNG will promptly repair or replace the defective Product. SAMSUNG may, at SAMSUNG's sole option, use rebuilt, reconditioned, or new parts or components when repairing any Product or replace Product with a rebuilt, reconditioned or new Product. Repaired/replaced leather cases and pouches will be warranted for a period of ninety (90) days. All other repaired/replaced Product will be warranted for a period equal to the remainder of the original Limited Warranty on the original Product or for 90 days, whichever is longer. All replaced parts, components, boards and equipment shall become the property of SAMSUNG. If SAMSUNG determines that any Product is not covered by this Limited Warranty, Purchaser must pay
