● Turning Power On

Hold down for at least two seconds.

● Turning Power Off

Hold down for at least two seconds.

▶ Select [Power off]. ▶ Select [OK].

Switching the Screen to English

On the desktop*: Select []. ▶ Select [設定]. ▶ Select [言語とキーボード].
▶ Select [言語(Language)を選択]. ▶ Select [English].

* The desktop represents the stand-by screen.

On the desktop: Select []. ▶ Select [Settings]. ▶ Select [Profile].



Making and Answering a Call

● Making a Call

On the desktop: Select [📞]. ▶ Enter the phone number you want to call.

▶ Select [Call].

To end a talk: Select [Disconnect].

To end a call: Select [Quit].

● Answering a Call

When the phone starts ringing, slide [📞] in the right direction.

To adjust the earpiece volume during a call: Press [🔊] / [🔊].

Storing and Recalling Address Book Entries

● Storing an Entry

On the desktop: Select [👤]. ▶ Select [Address Book].

▶ Select [≡]. ▶ Select [Add New Item]. ▶ Select the item you want to edit. ▶ Select [Save]. ▶ Select [Yes].

● Recalling an Entry

On the desktop: Select [👤]. ▶ Select [Address Book].

▶ Select the record you want to recall.

Using the Camera (Movie and Snapshot)

● Recording a Movie Clip

On the desktop: Select [📷]. ▶ Select [Video Camera]. ▶ Select [📹].

▶ Select [🛑] to stop recording. ▶ Select [Save] to store the movie.

To zoom in or out: Slide the touch screen left or right.

● Taking a Snapshot

On the desktop: Select [📷]. ▶ Select [Camera].

▶ Select [📷] to take a snapshot.

To zoom in or out: Slide the touch screen left or right.

Making an International Call

Ex: To call 212-123-△△△△ in the USA

On the desktop: Select [📞].

On the desktop: Select [👤]. ▶ Select [Settings].

▶ Select [Call Settings]. ▶ Select [Call/Message].

▶ Select [Answering memo setting].

Repeat the above operation to disable the Answer Memo.

This device was tested for typical body-worn operations with the back of the handset kept 1.5 cm from the body.
