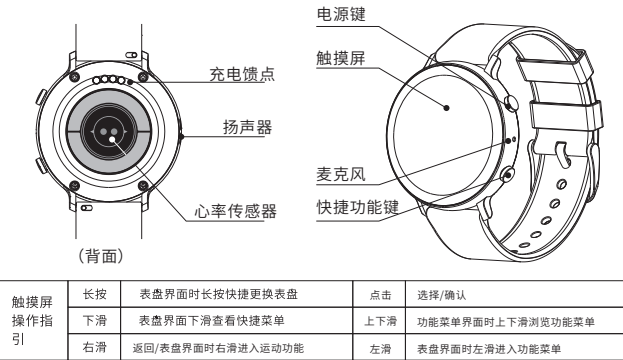

2 开关机说明

开机

- 关机状态下，长按电源键开机。
- 关机状态下，连接充电器进行充电时，手表自动开机。
- 超低电量开机时，需先连接充电器为手表充电30秒方可正常开机。

关机

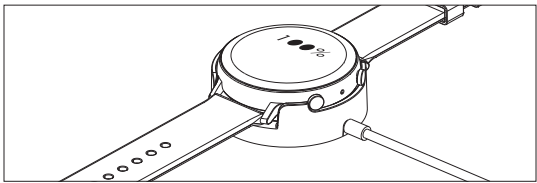
- 开机状态下，长按电源键关机。
- 超低电量振动提醒后手表自动关机。

恢复出厂

- 开机状态下，进入功能菜单，选择设置>恢复出厂。
- 恢复出厂设置后，手表会自动重启，重启后手表会与手机解除绑定，且所有用户数据清零。

3 手表充电

手表随附的配件有磁力充电底座，将充电座USB 数据线连接至正规厂商生产的电源插头或者电脑 USB接口。将手表的充电触点对准并贴合充电底座的金属触点，直到手表屏幕出现充电电量指示。完全无电状态充电时需要持续充电30秒左右才会在屏幕显示充电状态。



- 请使用包装内自带专用充电座充电，充电前确认手表充电触点干净、完整。
- 请使用额定输出电压5V±1A 及以上的正规厂商充电器或电脑USB 接口为手表充电。
- 在两小时左右即可将手表充满电，当充电指示显示100%表示电已充满。

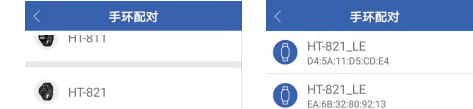

5 配对功能

1. 分别打开手机和手表的蓝牙开关(手表的蓝牙开关:左滑手表主界面>设置>蓝牙设置)。
2. 连接手机app:登录后进入app,点击 个人中心>绑定设备,在手环配对页面可选设备列表中选择点击HT-821,搜索附近蓝牙名称为HT-821_LE的设备,选择您要配对的设备,手表和手机将自动配对并同步数据。



3. 连接蓝牙通话功能:

- (1) 方式一:绑定设备后,进入app,点击 个人中心>开关设置>蓝牙通话>开始设置,选择搜索到的HT-821,点击配对,在弹出的蓝牙配对请求,同意通讯录的访问权限,再点击配对,则蓝牙通话功能配对成功。



- (2) 方式二:从手表进入蓝牙通话界面,搜索蓝牙设备,找到手机蓝牙名称并与之配对,手机端点同意配对请求,配对成功后在手机蓝牙菜单界面显示有两个蓝牙设备已连成功。

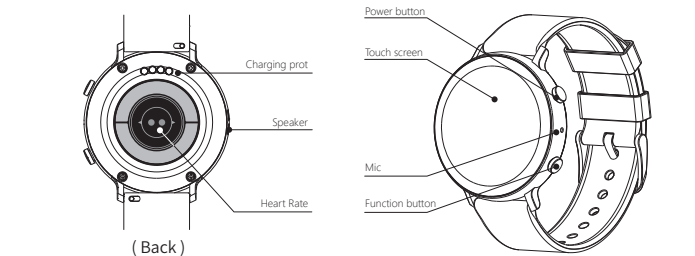

2 Power on/off

Power on

- Long press the power button to start the watch in shutdown state.
- The watch starts automatically when it is charged in shutdown state.
- When starting with ultra-low power, connect the charger to charge the watch for 30 seconds before starting.

Power off

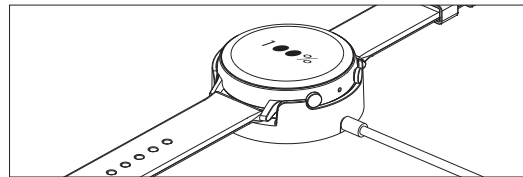
- Long press the power button to shut off the watch in power-on state.
- After ultra-low battery vibration reminder, the watch will automatically shut down.

Reset

- In the power-on state, enter the function menu and select Settings> Reset.
- After resetting, the watch will automatically restart. After restarting, the watch will be unbound from the phone and all user data will be cleared.

3 Charging instructions

The watch package comes with a magnetic charging base. Connect the USB plug of the charging base to a USB charger or a computer USB interface produced by a regular manufacturer. Align the charging feed point of the watch with the metal contacts of the charging base until the Charging instruction interface appears on the watch screen. When the watch is ultra low battery, it needs to continue charging for about 30 seconds to display the charging status on the screen.



- Please use the special charging base included in the box to charge. Please make sure the charging contacts of the watch are clean and complete before charging.
- Please use a regular manufacturer's charger with a rated output voltage of 5V/1A or above or a computer USB port.
- The watch will be fully charged about two hours. The screen shows 100% that means the battery is fully charged.

4 APP download

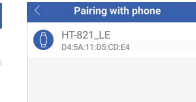
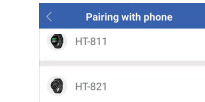
Scan the QR code on the right or search the "Lite Guardian KED" from AppStore, Google play and other mobile application market to download and install APP.

Android mobile phones: support the models with the original operating system of version 5.0 or above;
iPhone: support the models with the original operating system of version 8.0 or above;



5 Pair with phone

- Turn on the Bluetooth switch of the mobile phone and the watch respectively (the Bluetooth switch of the watch: swipe left on the main interface of the watch>Settings>Bluetooth settings).
- Connect to the app: After logging in, enter the app, click My Account> Device pairing, select HT-821 in the optional device list on the Pairing with phone page, and then search for the nearby Bluetooth device named HT-821_LE, and select the one you want to connect, The watch and phone are automatically paired and synchronized data.

3. Connect to the Bluetooth call function:

(1) Method 1: After binding the device, enter the app, click My Account>device Settings>Bluetooth calling>PAIRING, select the searched HT-821, click Pairing, in the pop-up Bluetooth pairing Request, agree to the access permission of the address book, and then click PAIR, the Bluetooth call function pairing is successful.



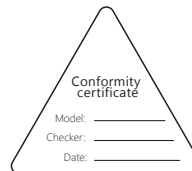
(2) Method 2: Enter the Bluetooth call interface in the watch, search for the Bluetooth device, find the Bluetooth name of the phone and pair with it, on the phone side agrees to the pairing request, after the pairing is successful, the Bluetooth menu interface of the phone shows that two Bluetooth devices have been connected.
