User Guide

- 1 Main Function Button
- 2 Volume Up Button
- 3 Volume Down Button
- 4 LED
- 6 USB Charging Port
- 6 Mic(BACK)

- Power On Press and hold the MFB until the LED flashes PURPLE and "Power On" voice prompts.
- Power Off Press and hold the MFB until the LED flashes PURPLE and "Power Off" voice prompts.
- Pairing While power is off, hold the MFB until the LED alternates flashing BLUE and RED and "Pairing" voice prompts. Once connected, LED will slowly flash BLUE.
- Olear Pairing Press and hold the MFB and volume down buttons until you hear one short tone.
 - 1 Play / Pause Press the MFB to play / pause.
 - Volume Up Press the volume up button. A tone will sound at maximum volume.
 - 3 Volume Down Press the volume down button. A tone will sound at minimum volume.
 - 2 Next Track Press and hold the volume up button.
 - 3 Previous Track Press and hold the volume down button.
 - 1 Answer Call / Hang Up Press the MFB.
 - Charging –The LED will flash RED while charging and turn BLUE once fully charged.
