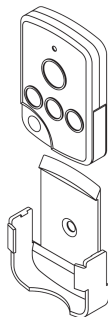

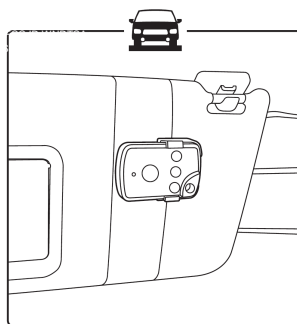

Programming

- 1- Open the case of the transmitter with an appropriate screwdriver
- 2- Use the transmitter which currently controls the motor and confirm that it is on the correct channel. Press and hold the Programm button (PROG) until the motor gives a short up/down bounce.
- 3- Press the (PROG) button of the TSA+ transmitter for 1sec, the LED will blink.
- 4- Press the desired channel (button) on the TSA+ you wish to add. The motor will give a short up/down bounce.
