
Airplane Adaptor

LOCATION OF CONTROL



CHARGING

Insert the USB Type-C cable into the USB port of the headphones as shown below and connect the other end to any USB adaptor or charging device. The Left LED indicator will turn solid RED while charging and become solid GREEN when fully charged. While charging, the headphones cannot be powered on or used.



Note: When the battery is low, the Right LED indicator flashes red twice every 5 seconds and the "battery low" voice prompt will be heard.


POWER ON/OFF

Power On:

Press and **HOLD** the Power button until the Right LED indicator lights blue.

Power off:

Press and **HOLD** the Power button until the Right LED indicator turns off.



Note: If not connected to a Bluetooth enabled device, the headphones will automatically power off after 5 minutes.


Using the audio cable:

When connecting an audio cable airPhones will disconnect from Bluetooth and play audio directly from the device.

BLUETOOTH PARING

Follow the steps below to pair your Bluetooth-enabled device.

- 1. While powered on, press and HOLD the Bluetooth button until the Right LED flashes red and blue indicating the headphones are in Bluetooth pairing mode (you can press and quickly release the Bluetooth button to exit Bluetooth pairing mode).
- 2. Open your device's Bluetooth menu.
- 3. Find and select BKH928 to pair.




4. Once paired, the voice prompt "Connected" will be heard and the Right LED indicator will flash blue every five seconds.

BLUETOOTH PARING

Disconnecting

To disconnect from a device, press and HOLD the Bluetooth button until the Right LED indicator flashes red and blue. You can now pair the headphones to another device.



Note: This feature is handy to quickly pair the headphones to another Bluetooth enabled vdevice.

ANC (ACTIVE NOISE CANCELLATION) MODES

The headphones include three ANC modes that offer different listening experiences. You can press the ANC button to cycle through the different modes below.



Noise Cancelling (Right LED indicator is green):

The Noise Cancelling mode is the default ANC mode and is automatically activated when the headphones are powered on. When the Noise Cancelling mode is active, the Right LED indicator of the headphones is solid green. About Noise Cancelling mode: This mode isolates your listening experience specifically to sound coming through the headphones and helps block unwanted outside noise.

Ambient Sound (Right LED indicator is white):

Press the ANC button once and the voice prompt "Ambient sound" is heard, the Right LED indicator of the headphones will turn solid white. About Ambient Sound mode: Safely enjoy your music by paying attention to the sounds around you. Using microphones built into the headphones, the Ambient Sound mode allows you to hear ambient sound even while wearing the headphones.

Note: The Ambient Sound mode does not enable you to hear all sounds around you. Certain sounds may not be heard well depending on the surrounding environment, type of music being played, or the volume level. Be careful when using the headphones in places where an inability to hear ambient sound would be dangerous.

Ambient Sound and Noise Cancelling Off (Right LED indicator is off): Press the ANC button twice and the voice prompt "Ambient sound and noise cancelling off" is heard, the Right LED indicator will turn off.

Note: In this mode, both Noise Cancelling and Ambient Sound modes are turned off. You can press the ANC button again to turn Noise Cancelling mode back on.

TOUCH CONTROL

The headphones include a multifunction touchpad located over the right earcup. Use the following gestures to control the audio playback and answer calls.

Play/Pause: Tap twice.

Next Track: Tap 3 times

Previous Track: Tap 4 times.

Volume: Slowly swipe up or down.

Answer a Call:

Double tap during an incoming call.

Rejecting a Call:


Touch and **HOLD** during an incoming call.


Voice Assistant:

Touch and **HOLD** until the default voice assistant of your device is activated. You can touch and **HOLD** again to cancel (this may not be supported on all devices).

Monitor:

Place the palm of your hand over the right earcup, the music is muted until you release your palm from the earcup.





LED INDICATORS

The headphones include two LED indicators, the Right LED indicator and the Left LED indicator.
