






① Car Mount    ② Locking Bolt    ③ Vent Clip



- EN** • Vent Clip can only be installed on air event blades less than 4.5mm (0.18in) thick.  
• When installing Vent Clip, only 7.5mm (0.3in) apart from vehicle vent blade can be installed.
