Setting Up Your Phone


Follow these step-by-step instructions to set up your A10L. Power off the phone **before** inserting any cards!



- 1 Remove Back Cover
 - Remove the back cover by prying the lower left corner of your device.
- Insert SIM
 - Orient SIM card to match diagram on slot.
 - SIM (Nano) support 4G LTE connections.



- Insert the Battery
 - Align the battery contacts, then insert the battery contact-first.
- Replace Back Cover
 - After installing the SIM card, memory card, and battery, align the cover and snap it closed. Be sure to press all around the edges to ensure a secure fit.
- Charge/Sync
 Plug in the micro USB connector to charge the phone or transfer data.



Warning:

SIM cards are small enough to become a choking hazard, so please keep them away from children & pets. SIM cards are also quite delicate. Please be careful when handling your card.

Safety information

 This section contains important information about the operation of your device, it also contains information about how to use the device safely. Read this information carefully before using your device.

Electronic device

Do not use your device if using the device is prohibited.

Do not use the device if doing so causes danger or interference with other electronic devices.

Interference with medical equipment

- Follow rules and regulations set forth by hospitals and health care facilities. Do not use your device where prohibited.
- Some wireless devices may affect the performance of hearing aids or pacemakers. Consult your service provider for more information.
- Pacemaker manufacturers recommend that a minimum distance of 15 cm be maintained between a device and a pacemaker to prevent potential interference with the pacemaker. If using a pacemaker, hold the device on the side opposite the pacemaker and do not carry the device in your front pocket.

Protecting your hearing when using a headset

- To prevent possible hearing damage, do not listen at high volume levels for long periods.
- Using a headset at high volumes may damage your hearing. To reduce this risk, lower the headset volume to a safe and comfortable level.
- Exposure to high volumes while driving may cause distraction and increase your risk of an accident.

Areas with flammables and explosives

- Do not use the device where flammables or explosives are stored (in a gas station, oil depot, or chemical plant, for example). Using your device in these environments increases the risk of explosion or fire, in addition, follow the instructions indicated in text or symbols.
- Do not store or transport the device in containers with flammable liquids, gases, or explosives.

Traffic security

Operating environment

- Ideal operating temperatures are 0 °C to 35 °C. Ideal storage temperatures are -20 °C to 45 °C, Extreme heat or cold may damage your device or accessories.

- To protect your device or accessories from fire or electrical shock hazards, avoid rain and moisture.
- Keep the device away from sources of heat and fire, such as a heater, microwave oven, stove, water heater, radiator, or candle.
- Do not place sharp metal objects, such as pins, near the earpiece or speaker. The earpiece may attract these objects and result in injury.
- Stop using your device or applications for a while if the device is overheated. If skin is exposed
 to an overheated device for an extended period, low temperature burn symptoms, such as

Battery safety

Environmental protection

Safety precautions

- . Use of wireless hands-free system (headphone, headset) with a low power Bluetooth emitter.
- . Make sure the cell phone has a low SAR.

- . Use cell phone when the signal quality is good.
- People having active medical implants should preferably keep the cell phone at least 15 cm away from the implant.

Battery Caution

Your wireless phone is a radio transmitter and receiver, It is designed and manufactured not to exceed the emission limits for exposure to radio frequency (RF) energy set by the Federal Communications Commission of the U.S. Government, These limits are part of comprehensive guidelines and establish permitted levels of RF energy for the general population. The guidelines are based on standards that were developed by independent scientific organizations through periodic and thorough evaluation of scientific studies. The exposure standard for wireless mobile phones employs a unit of measurement known as the Specific Absorption Rate, or SAR. The SAR limit set by the FCC is 1.6 W/kg. * Tests for SAR are conducted with the phone transmitting at its highest certified power level in all tested frequency bands. Although the SAR is determined at the highest certified power level, the actual SAR level of the phone while operating can be well below the maximum value. This is because the phone is designed to operate at multiple power levels so as to use only the power required to reach the network. In general, the closer you are to a wireless base station antenna, the lower the power output, Before a phone model is available for sale to the public, it must be tested and certified to the FCC that it does not exceed the limit established by the government adopted requirement for safe exposure. Hearing-Aid Compatibility (HAC) Statement

The A10(NS502L) has been tested for hearing aid compatibility. This device has an M4 and T3 rating. When some wireless devices are used near some hearing devices such as hearing aids and implants, users may detect abuzzing or humming noise. Some hearing devices are more immune than others to this interference noise. Wireless devices may also vary in the amount of interference they generate.

The ratings for compatibility of digital wireless devices with hearing aids are described in the American National Standards Institute (ANSI) C63.19 standard:

M-Rating: Phones rated M3 or M4 meet FCC requirements and are likely to generate less interference with hearing devices than phone that are not labeled. M4 is the better/higher of the two ratings.

A10L(N5502L) is rated M4.

T-Rating: Phones rated T3 or T4 meet FCC requirements and are likely be more usable with hearing devices' telecoil than unrated phones. T4 is the better/higher of the two ratings.

A10L(N5502L) is rated T3.

The more immune the hearing aid device is, the less likely one is to experience interference noise from the wireless phone. Hearing aid devices may also be rated. Adding the rating of the hearing aid and the phone would determine probable usability:

- 1. Any combined rating equal to or greater than six offers the best use.
- 2. Any combined rating equal to five is considered normal use.

The ratings are not guarantees. Results will vary depending on the user's hearing device and hearing loss. If your hearing device happens to be vulnerable to interference, you may not be able to use this device successfully. Trying out this device with your hearing device is the best way to evaluate it for your personal needs. This device has been tested and rated for use with hearing aids for some of the wireless technologies that it utilizes. However, there may be some never wireless technologies used in this phone that have not been tested yet for use with hearing aids.
