**Do not throw, avoid the damage caused by falling.**

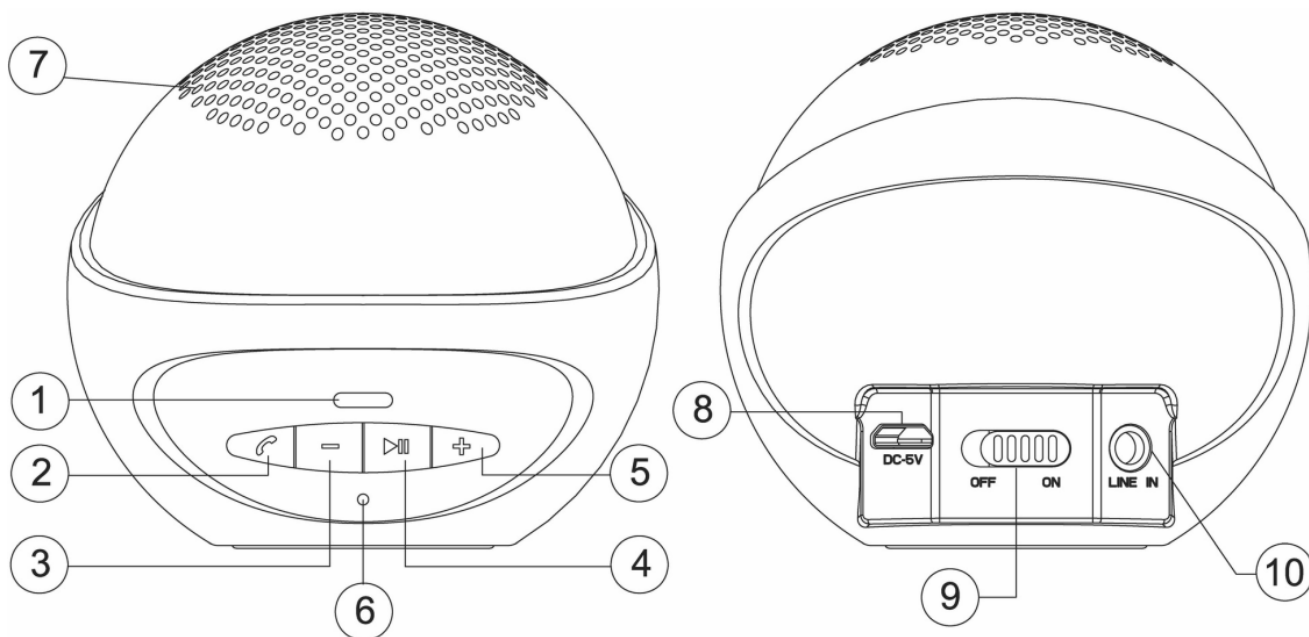
**Please do not disassemble by repair and transform the product;**

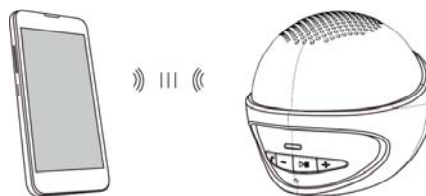

## 7. Functional Specification

On: switch on the power of the speakers, sound will "beep, beep" prompt, tooth lights flashing at the same time.

On the bluetooth connectivity, After open the power supply, double click on the "☎" or by "▶▶" long, bluetooth speakers into the search matching state, the bluetooth indicator light flash, a bluetooth device can search to the speakers, click on the match, after the success of the connection, the bluetooth indicator light flash slowly, the speakers will make the du a hint sound. Within 10 minutes after the power to open the bluetooth speakers find any bluetooth equipment will automatically shut down.

If the next to connect again need to switch to electricity, the machine is back to league final equipment function; After successful connection of equipment to open the bluetooth automatically connected or click "▶▶" connect. Warm prompt: if the connection fails, please shut down or restart may battery is insufficient, please recharge.

Bluetooth music playback: after the success of the bluetooth connection, equipment can play music directly or by speakers on "▶▶". In the play process short according to "▶▶" pause, press the "▶▶" play in the suspension.

Hands-free calls: bluetooth stereo with mobile phone after the connection is successful, when the caller id, sound will "beep" prompt tone; According to "☎" answering the phone/long according to reject, can replace mobile phone talking to each other, and then according to the end of "☎" hang up the phone call, also can be long press "☎" to redial the bottom number phone

LINE IN: the audio source to provide audio accessories LINE respectively inserted into the sound box LINE IN audio input interface and computer music player, such as audio jack, LINE indicator light bluetooth will automatically shut down; Play put start playing, the machine will immediately music sounded, volume, selections, etc., controlled by the player freedom.

Warm prompt: "MM" button is invalid when LINEIN state, pause/play is controlled by a bluetooth device but time according to the "MM" will reopen bluetooth LINE can be done IN the bluetooth audio output.

Charging: standby or off charging. Will provide USB power cord attachment Micro USB end insert USB power switch box, the other end to connect the computer USB port or USB charger, start charging, after full charge indicator.
