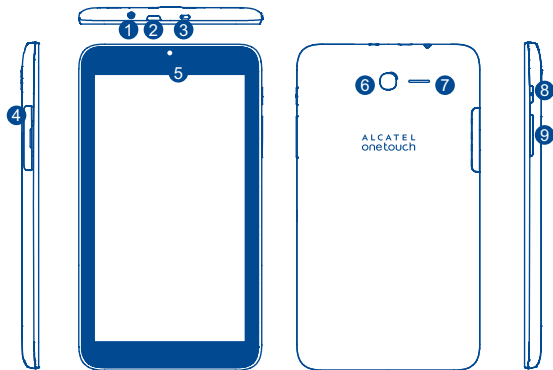

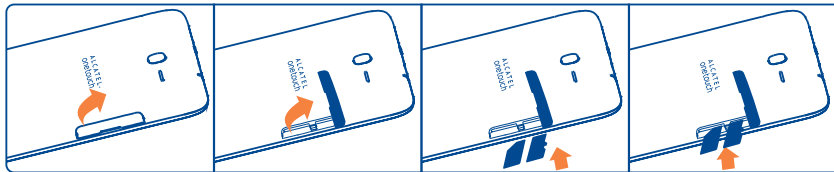

Normally, the tablet will power on and display the Home Screen when you press and hold the Power key, but if the tablet is low on power, a battery icon will appear indicating that you should charge the device before use. 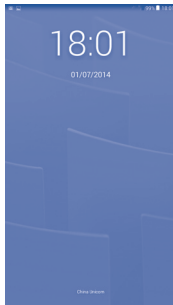
This device cannot be charged through USB computer connection. Please plug in your charger before first usage.



1.2 Home screen

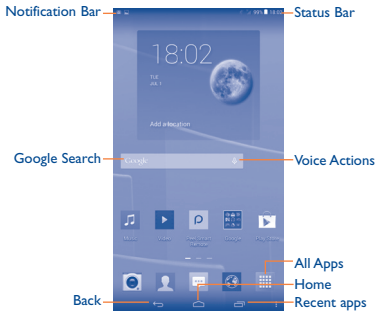
Your device includes three pages of Home screen, giving you more space to add your own favorite apps, folders and widgets, all accessible with a single touch. To switch between screens, slide your finger left or right.

1.2.1 Lock/Unlock your screen




Once your device is powered on, it shows a locked screen interface, which is set as default. Slide your finger to the right to unlock the screen.

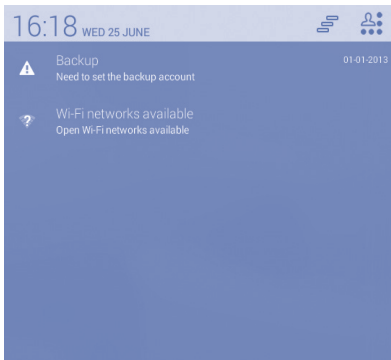
1.2.2 Icons on your screen



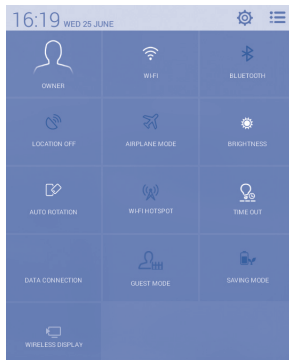
Name	Description
Google Search	Touch to access the Google search engine.
Voice Actions	Use Voice Actions to watch a video, send email, set alarm, get directions, etc.
All Apps	Touch to show a complete app list interface.
Back	Go back to the previous menu or screen.
Home	Return to the home screen.
Recent apps	Touch to view recent apps.

On the upper left corner, a Notification Panel will popup when you place your finger on the notification bar and slide down. Touch the right top icon  (Picture 1) to clear all event-based notifications (other ongoing notifications will remain).

Touch  to open the Quick Setting Panel (Picture 2). Touch  back to Notification Panel. On the Quick Setting Panel, touch icons to enable/disable functions or to change modes.

1.3 Apps and widgets

1.3.1 Apps

The Applications (apps) list contains all pre-embedded and newly installed apps. To access the apps list, touch the all apps key  from Home screen.

1.3.2 Widgets

By touching and holding an empty area in the Home screen, you can switch to widgets interface.

1.3.3 Get more apps

Touch the **Play Store** icon  to get more apps.

1.3.4 Create and manage shortcut on desktop

Touch and hold an icon on **All APPS** or **DOWNLOADED** interface, drag it to the right place you want. Overlap icons together will build a folder. You can name the folder by touching the tag in the top left corner.

1.3.5 Remove app icon from desktop

Touch and hold the item to be removed to activate Move mode, drag the item up to the top of the Remove icon , and release the item after the Remove icon turns red.

1.3.6 Uninstall apps

Press  to enter all Apps, then touch and hold the application icon you want to uninstall, drag it over the Remove icon , and release it after the Remove icon turns red.





1.4 Basic operation

1.4.1 Power on your device

Press and hold the **Power** key until the tablet powers on. It will take a few seconds before the screen lights up.

1.4.2 Power off your device

- Press and hold the **Power** key about 3 seconds until the options appear, select "Power off " to power off your device.
- Press and hold the **Power** key about 10 seconds to shut down your device.

1.4.3 Stand-by mode

Press the **Power** key once to shut down the screen and enter stand-by mode.

Note: Without operation, the product will enter stand-by mode automatically. Press **Power** key once to wake it up.

1.4.4 Restart

Press and hold the **Power** key about 3 seconds until the options appear, select "Restart" to restart your device.

- When your device is out of function, press and hold the **Power** key about 10 seconds to shut down your device. Then press the **Power** key to restart.

1.4.5 Connecting to a computer via USB

After connecting your device to computer by USB, you can transfer files between your device and the computer.

Note: Files copied to your tablet are not available until USB data cable is disconnected from the PC completely. Use a USB 2.0 version or higher to connect the devices.


1.4.6 Change your wallpaper

You can change your wallpaper following the steps **Settings > Display > Wallpaper**.



1.4.7 Wi-Fi

To turn Wi-Fi on and connect to a wireless network:

- Touch Wi-Fi icon on Quick Setting Panel, to turn on/off Wi-Fi.
- Select Settings, touch  beside Wi-Fi to turn on/off Wi-Fi.
- Touch a Wi-Fi network to connect. If the network you selected is secured, you are required to enter a password or other credentials (You may need to contact the network operator for details). When finished, touch **Connect**.

Tip: To extend the battery life, turn off Wi-Fi when you're not using it.

1.4.8 Zoom in/out

Draw your fingers apart/together to zoom in/out (Web browser, Gallery etc...).



2 Settings

2.1 Device

2.1.1 Sound

You can set **Volumes, Audible selection and Screen lock sound** to your preference with the Volume up/down key, or by touching **Settings > Sound**.

2.1.2 Display

Touch **Settings > Display**, you can see the items:

- **Lock screen notification** Show notifications on lock screen.
- **Wallpaper** Set your wallpaper.
- **Brightness** Adjust your screen to a comfortable brightness.
- **Auto-rotate screen** Touch to select whether rotate screen automatically or not.
- **Sleep** Set Screensavers time.
- **Daydream** Select an animation effect shows in standby status.
- **Font size** Select a suitable font size for your tablet.

2.1.3 Storage

Touch **Settings > Storage** to view the memory using status.

2.1.4 Battery

Touch **Settings > Battery Manager** to check the battery power and its service status.

2.1.5 APPs

Touch **Settings > Applications** to check the APP status.

2.2 Personal

2.2.1 Language & input

Touch **Settings > Language & input** to view or set system language and input methods.

- **Language** Set the system language.
- **Keyboard & input methods** Check and select all the input methods installed in the tablet.

2.2.2 Backup & reset

You can back up settings and other data associated with one or more of your Google Accounts. If you need to replace or factory reset your device, you can restore your data for any accounts that were previously backed up.

Touch **Settings > Backup & reset**

Tips: Please make sure that all the important data have been backed-up before you run factory data reset, for this function will eraser all user installed apps and data; and ensure that the remaining battery is more than 50%.

2.3 System

2.3.1 Date & time

Touch **Settings > Date & time**, to set date, time and format.

2.3.2 About tablet

Touch **Settings > About tablet** to check legal information, tablet status and software version, etc.

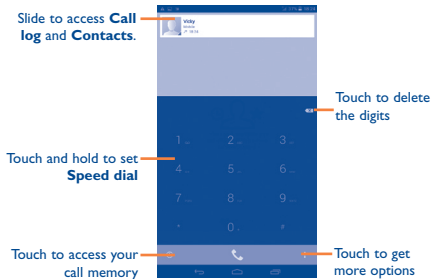
3 Phone call




3.1 Placing a call

You can easily launch a call using Phone. Touch all apps key  to enter ALL APPS, then select  Touch  to display the keyboard. Enter the desired number from the keyboard directly or select a contact from **Contacts** or **Call log** by sliding or touching tabs, then touch  to place the call. The number you entered can be saved to **Contacts** by touching **Add to Contacts**.

To hang up a call, touch .



3.2 Answering or rejecting a call

When you receive a call, drag the icon  rightward to answer the call, leftward to reject the call, upward to reject the call by sending a preset message.

• TRAFFIC SAFETY

Given that studies show that using a device while driving a vehicle constitutes a real risk, even when the hands-free kit is used (car kit, headset...), drivers are requested to refrain from using their device when the vehicle is not parked.

SAR compliance for body operation is based on a separation distance of 1.0 cm between the device and the human body. During use, the actual SAR values for this device are usually well below the values stated above. This is because, for purposes of system efficiency and to minimize interference on the network, the operating power of your device is automatically decreased when full power is not needed. The lower the power output of the device, the lower its SAR value.

Body-worn SAR testing has been carried out at a separation distance of 1.0 cm. To meet RF exposure guidelines during body-worn operation, the device should be positioned at least this distance away from the body.

If you are not using an approved accessory ensure that whatever product is used is free of any metal and that it positions the device the indicated distance away from the body.

Organizations such as the World Health Organization and the US Food and Drug Administration have suggested that if people are concerned and want to reduce their exposure they could use a hands-free accessory to keep the wireless device away from the head or body during use, or reduce the amount of time spent on the device
