- 3. To adjust the volume, press the button to lower or press + to raise the volume. The volume can also be controlled from your paired Bluetooth device.

- 5. To change the track from your headphone, short press the ◄◄ button to listen to the previous track or short press ►► to skip to the next track. You can also change the track from your paired Bluetooth device
