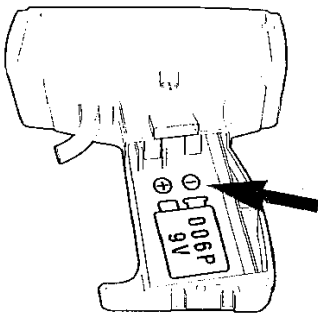
### BATTERIES

Your Tyco® R/C vehicle is powered by two different types of batteries:

- One 9 volt alkaline battery (for transmitter).
- Two AA type alkaline batteries (for vehicle). The 9 volt transmitter battery will last much longer than vehicle batteries.

BATTERIES NOT INCLUDED.

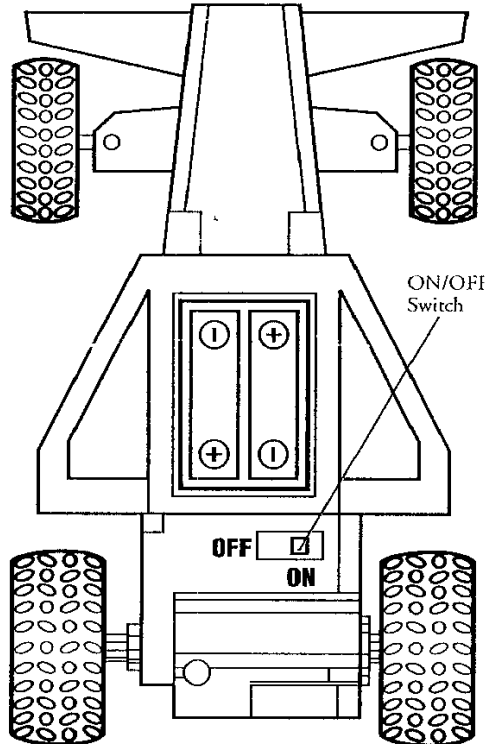
### TRANSMITTER



#### BATTERY INSTALLATION

- Push the battery holder cover down to remove.
- Install one 9 volt battery with polarity (+,-) as shown inside battery compartment.
- Replace battery holder cover.

### VEHICLE



#### Battery Installation

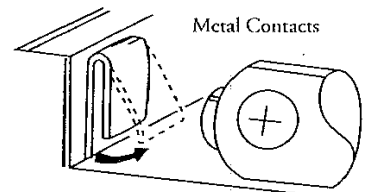
- Push battery door open in direction of arrow on door.
- Install batteries with polarity (+,-) as shown inside battery compartment.
- Close battery cover.

#### Important Battery Information

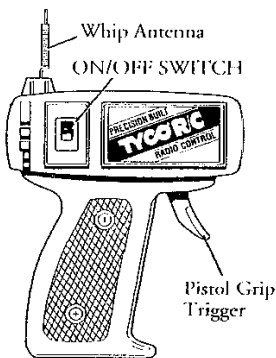
- Do not mix old and new batteries.
- Do not mix alkaline, standard (carbon-zinc), or rechargeable (nickel-cadmium) batteries.
- Remove batteries if toy will not be used for a long period of time.

#### Battery Contacts

- Bent or dirty contacts may result in loss of power.
- If battery does not fit correctly, carefully pry out metal contact as shown in diagram.



### OPERATION

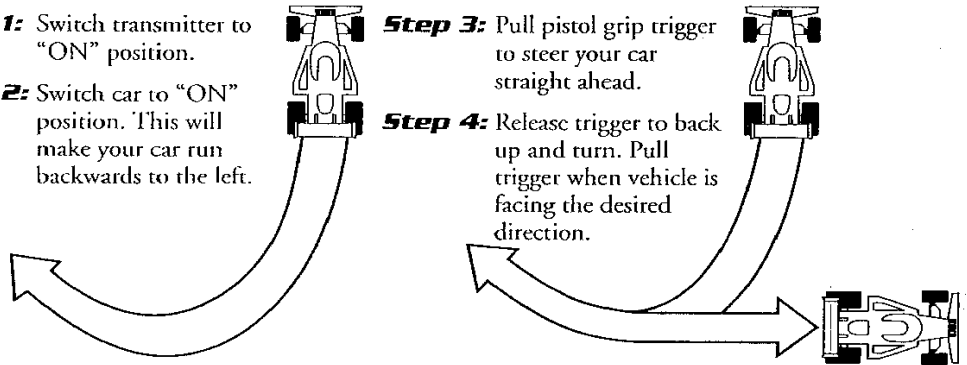


**Step 1:** Switch transmitter to "ON" position.

**Step 2:** Switch car to "ON" position. This will make your car run backwards to the left.

**Step 3:** Pull pistol grip trigger to steer your car straight ahead.

**Step 4:** Release trigger to back up and turn. Pull trigger when vehicle is facing the desired direction.

If product is found to have been misused or abused, it will not be covered by this warranty, and you will be advised. You will also be advised of the cost of repairs if you desire them.

If your product is sent to Mattel without a dated sales receipt, this may result in the product not being covered by our warranty.

For repairs of your product after the expiration of the 90-day warranty period, an estimate of the cost of the repair will be sent to you, if requested.

This warranty does not cover any claim concerning worn or defective batteries, or damage caused to your vehicle from defective batteries.
