

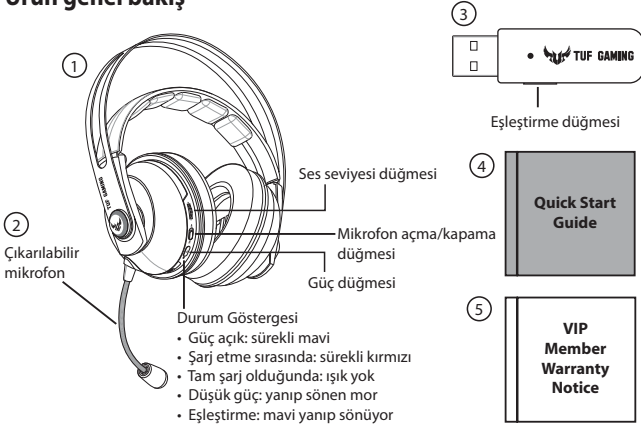

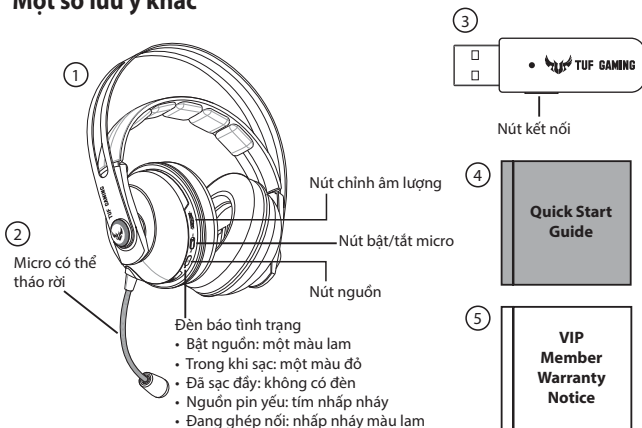

Bắt đầu sử dụng

1. Kết nối USB phát không dây 2.4GHz với thiết bị của bạn.
2. Nhấn nút nguồn trong 2 giây để bật tai nghe không dây chơi game TUF H7, sau đó nhấn nút ghép nối trên USB thu phát không dây trong 2 giây để ghép nối chúng.
3. Đèn LED trên tai nghe không dây chơi game TUF H7 sẽ chuyển sang sáng cố định, cho biết tiến trình kết nối đã hoàn tất.
