INTRODUCTION - WIPCLIP SPRINGBOARD MODULE

The Tellus WIPClip™ CDPD Springboard™ module is a CDPD (Cellular Digital Packet Data) wireless data modem designed for Handspring™ Visor™ PDA (Personal Digital Assistant). The WIPClip easily snaps into the Springboard expansion slot with a 64-pin connector.

The WIPClip modem, mated with the Handspring Visor, gives users mobile data capabilities, enabling wireless access to email, corporate Intranet and the Internet at speeds up to 19.2 kbps. Inserting the WIPClip modem into the Visor's Springboard expansion platform adds just 3.2 ounces to the Visor and fits perfectly in a shirt pocket. The WIPClip features a rechargeable Lithium Ion battery through the Hot-Sync cradle or the Handspring travel charger without removing the WIPClip modem. The WIPClip uses AT Commands and relies on the TCP/IP stack of the PDA for network access. Since the modem is "plug-and -play", the AT Commands are transparent to the user. For those wishing to utilize the AT Commands, a built-in terminal program has been provided.

INTRODUCTION TO CDPD (WIRELESS IP)

System Overview

With the WIPClip module integrated into your Visor, it connects to the public Cellular Digital Packet Data (CDPD) network using Internet Protocol (IP) addresses or to a Virtual Private Wireless IP network.

When you send or receive data, CDPD networks use advanced error correction techniques to ensure that your data is received error free. In addition, CDPD networks provide data encryption and authentication services - adding security and privacy - to protect your information as it moves across the network.

Thus, CDPD is a reliable, interference-reduced, wireless data-transfer system that provides the freedom to communicate sensitive information in a secure wireless environment.

Subscription to a CDPD Service

Subscription to a CDPD Network is required for the WIPClip/PDA to function. Tellus Technologies does not include CDPD service activation as part of the WIPClip product. The user must subscribe to a CDPD service just as you subscribe to a cellular or paging service to activate your mobile phone or pager.


The carrier records the unique and pre-programmed Equipment Identifier (EID), assigns a Network Equipment Identifier (NEI - an IP address), and sets up a billing account, similar to the assignment of a cellular phone number.

If you are switching CDPD service providers, you will need to contact the wireless provider of your choice and follow their instructions regarding configuration of the modem to work on their network and to avoid Roaming charges.

Printed on the WIPClip label are the EID, Serial Number (S/N), FCC and Industry Canada ID's and compliance statement. Copy the EID and S/N onto the quick reference form at the end of this WIPClip User Manual. This information offers a convenient, alternate location making it easier to reference your unit if you need to contact the Tellus Help Desk.

CDPD System Description

It is important to understand how a CDPD Network works and how the WIPClip sends and receives data. It is assumed that the WIPClip has been attached to the Visor via the Springboard slot. The combination of the WIPClip and PDA becomes the Mobile End System, (MES).




The MES is connected via the air interface of the Cellular Digital Packet Data (CDPD) Network to the Mobile Base Station (MDBS). The MBDS is connected to a Serving Fixed End System (FES) via the Mobile Data Intermediate System and the Internet.

The FES could be another MES working under the CDPD cloud. In this configuration, the MDIS would not route the data to the Internet, but to the appropriate MBDS for transmission to the other MES.

INSERTING THE WIPCLIP INTO THE SPRINGBOARD SLOT OF THE VISOR

Operation is simple, you insert the WIPClip module into the Springboard slot of the Handspring Visor. Depending on the Visor model you have purchased, use the HotSync® cradle or available travel charger to charge the internal battery of the WIPClip. Once the modem is fully charged adjust the antenna to the appropriate position as shown on the pictures below. The user then clicks on the browser icon, of your preferred wireless service provider, to instantaneously connect to the CDPD network.

For better RF reception, it is recommended that your hand be kept away from the antenna. To handle the WIPClip/Visor, the left index finger rests directly behind the modem. The thumb then rests in front of the Visor panel to access the features on the screen and control buttons.




Optimal Antenna Positions

CHARGING THE WIPCLIP

Recharging the WIPClip modem is easy. The normal battery operation is between 3.5 to 4.2 Volts. If your battery level falls below 3.59 Volts, a warning message will appear, "Low Modem Battery", as shown below. When this dialog box appears, replace the Visor and WIPClip to the HotSync recharging cradle or simply plug the Handspring travel charger into the Visor. It takes a few minutes for the battery to accurately show the charging condition.

The green battery LED will flash slowly indicating that your battery is in process of recharging. If your unit still does not operate, make sure that the unit is placed correctly on the cradle or fully connected to the travel charger.

WARRANTY COVERAGE

Tellus Technology, Inc. (Tellus) warrants that the Tellus WIPClip wireless data card and accessories conform to Tellus' published specifications for such Product at the time of purchase, and will be free from defects in materials and workmanship, under normal operating use and service, for one year from the date of original purchase (not from date of Product activation or registration on the network). This warranty extends to the final consumer of the Product only. Tellus at its option, will at no charge, either repair (with new or reconditioned parts), replace (with a new or reconditioned Product), or refund the purchase price of the Product during the first 60 days from the date of purchase. Repaired/replacement Products are warranted for either 60 days or the remainder of the original warranty period, whichever is longer. All replaced items become Tellus' property.

What the Warranty Does Not Cover

This warranty also does not cover optional rechargeable batteries if: (a) the battery is charged by other than our approved battery chargers; (b) any of the seals on the battery is

broken or shows evidence of tampering; or (c) the battery is used in equipment or service other than the product for which it is specified.

In addition, Tellus specifically disclaims liability for: (a) range, coverage, traveling, availability or operation of any communications system(s) on which the Product operates; or (b) any data stored in or used with the Product, including recovery costs of such data.

Warranty Service Guidelines

The user must provide proof of purchase bearing the date of purchase in order to receive warranty service. In some cases, the provider who sold or installed your Product will facilitate your warranty service. Tellus will provide warranty service through Tellus-authorized Product repair facilities or you may return the Product directly to Tellus for warranty service.
