

Installing the Handset Battery



Cover

- 1. Locate battery and battery door which are packaged together inside a plastic bag and are separate from the speakerbox/handset
- 2. Locate the battery compartment on the back of the speakerbox/handset

3. Plug the battery pack cord into the jack inside the compartment. NOTE: To ensure proper battery installation, the connector is





4. Insert the battery pack.

- 5. Close the battery compartment by pushing the door up until it snaps into place.
- 5. Plug the AC power adaptor cord into the power jack on the back of the speakerbox/handset and the other end into an electrical outlet. The charge indicator turns on, verifying the battery is charging.



- Use the touch-tone pad to enter a name (up to 15 characters). More than one letter is stored in each of the number keys. For example, to enter Bill Smith, press the 2 key twice for the letter B. Press the 4 key 3 times for the letter I. Press the 5 key 3 times for the letter L. Press the 5 key 3 times for the second letter L, and press the 1 key to insert a space between the first and last name. Press the 7 key 4 times for the letter S; press the 6 key once for the letter M; press the 4 key 3 times for the letter I; press the 8 key for the letter T; press the 4 kev twice for the letter H.
