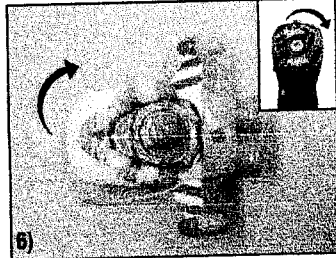
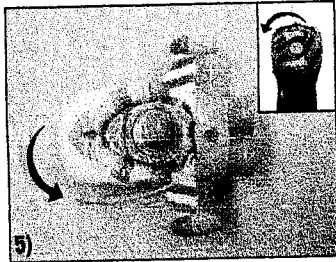


- 1) Open battery compartment on the underside of the radio control and insert one 9 Volt battery and close cover.
- 2) Open battery compartment on the underside of charger and insert 3 AAA batteries and close cover.
- 3) Place the car on the charger for charge-up process which show in photo 3.  
Press the black button and the red LED will ligh up.  
Wait until the red LED turn OFF
- 4) Turn power switch ON the side of radio control. Red LED light when lit indicates power is ON.



- 5 & 6) Turn wheel to the left or right to turn skateboard left or right.
- 7 & 8) Move trigger on the underside of remote forward and backward to control forward and backward motion.

- Do not use rechargeable batteries.
- Non-rechargeable batteries are not to be recharged.
- Different types of batteries or new and used batteries are not to be mixed.
- Only batteries of the same or equivalent type as recommended are to be used.
- Batteries are to be inserted with the correct polarity.
- Exhausted batteries are to be removed from the toy.
- The supply terminals are not to be short-circuited.
- Do not dispose of batteries in fire, batteries may explode or leak.
- 3 AAA Batteries required for Skateboard (Not Included).
- One 9V Battery required for Radio Control (Not included).
