# CARE AND USE

- 1. Cleaning your Trago Cap + Bottle: The Trago Cap is NOT dishwasher safe. But, feel free to put the insulated bottle in the dishwasher. We recommend hand washing the cap with soap and water. Make sure the battery cap is closed tightly!
- 2. Always On: Once you put the battery in the cap, Trago is, "always on." Trago will notify you if the battery is low in the Trago App. Batteries can be purchased at www.trago.co or at your closest pharmacy or retailer.

# TROUBLE SHOOTING

- **1.** Make sure the strap is attached and undamaged. The strap is required for proper function of the Trago Cap.
- **2.** Make sure BT is enabled on your phone/device.
- 3. Close and re-launch the App.
- **4.** Remove and re-install the battery.
- **5.** Replace the battery with a new one.
- 6. Un-install and re-install the app.
- **7.** Un-pair and re-pair the Cap to your device.
- **8.** If your bottle is full of ice and no water, the Trago Cap will not properly function.
- 9. Make sure that the Trago sensors are clean and clear of debris and residue for accurate measurements.
