

Setup Instructions

- Press and hold the power button for two seconds to turn the headphones ON.
- 2. Open the Bluetooth settings on your device, search and select "Soundguards", follow the device instructions to finish the pairing process.
- a. If you wish to connect via AUX instead, skip this step and instead plug one end of an AUX cable into your device and the other into the headphone jack.
- **b.** To switch to AUX mode, press the Power/Multi-function button.
- 3. Your headphones are now ready for use!
- 4. To charge your headphones, plug the USB-C charging cable into the port on the headphones and connect the other end into a USB power source.
- The LED will flash red while charging and turn blue once fully charged.
- **6.** Slide the Transparency mode ON/OFF switch to hear/isolate environmental sound.
