







TERMS OF USE: All Ethernet cabling runs must use CAT6. It is the customer's responsibility to follow local country regulations and indoor cabling requirements.

### **Network Topology Requirements**

- A DHCP-enabled network for the UniFi Switch to obtain an IP address (connected devices will also obtain IP addresses after deployment)
- A Unifi Cloud Key or management station running the Unifi Controller software v5.4.x or above, located either on-site and connected to the same Layer 2 network, or off-site in a cloud or NOC



Sample Network Diagram







## **Installation Requirements**

- Phillips screwdriver
   For indoor applications, use Category 5 (or above) UTP cabling approved for indoor use.
- For outdoor applications, shielded Category 5 (or above) cabling should be used for all wired Ethernet connections and should be grounded through the AC ground of the PSU.

We recommend that you protect your networks from harmful outdoor environments and destructive ESD events with industrial-grade, shielded Ethernet cable from Ubiquiti Networks. For more details, visit: www.ubnt.com/toughcable



Note: Although the cabling can be located outdoors, the UniFi Switch itself should be housed inside a protective enclosure.

#### Hardware Installation

 Attach the UniFi Switch to the rack using the four Mounting Screws. (If the rack has square slots, then use the Cage Nuts with the Mounting Screws.)



3. Connect the other end of the Power Cord to a power outlet.

# **Connecting Ethernet**

Connect an Ethernet cable from your computer or host system to any port of the UniFi Switch.



2. Connect Ethernet cables from the Ethernet ports of your devices to the other numbered ports of the UniFi Switch.

# **Using SFP Ports**

To use an SFP port:

- 1. Remove the protective plug covering the SFP port.
- 2. Plug a compatible fiber module into the SFP port.



3. Connect a fiber optic cable to the fiber module. Then connect the other end of the cable to another fiber device.



# Using SFP+ Ports (US-L2-48-POE only)

To use an SFP+ port:

- Remove the protective plug covering the SFP+ port.
   Plug a compatible fiber module into the SFP+ port.



3. Connect a fiber optic cable to the fiber module. Then connect the other end of the cable to another fiber device.




# Installing a Secondary PSU Module (Optional)

1. On the back of the UniFi Switch, depress the four locking tabs on the Bay Cover and remove it.



2. Insert the PSU module until the *Lock Lever* engages and locks into place.



### Software Installation

Download and install the latest version of the UniFi Controller software at **downloads.ubnt.com/unifi** and follow the on-screen instructions.



Note: If you already have UniFi Controller v5.4.x or higher installed, skip to the section, *Adopting the UniFi Switch*.

After you have installed the software and run the UniFi Installation Wizard, a login screen will appear for the UniFi Controller management interface. Enter the admin name and password that you created and click **Login**.



You can manage your network and view network statistics using the UniFi Controller management interface.

To adopt the UniFi Switch, proceed to the Adopting the UniFi Switch section.

# Adopting the UniFi Switch

 From the UniFi Controller dashboard, click **Devices** in the left menu bar.



 On the Devices screen, locate the UniFi Switch in the list of devices under the Name/MAC Address column. To adopt the UniFi Switch, click Adopt.



3. The System LED on the UniFi Switch will turn blue to confirm that it has been successfully adopted.

To configure PoE settings, proceed to the *Configuring PoE Settings* section.

# **Configuring PoE Settings**

The RJ45 ports are auto-sensing by default, so 802.3af/at devices can be plugged in and automatically receive Power over Ethernet. To disable or enable PoE, follow these instructions:

 On the Devices screen, locate the UniFi Switch in the list of devices under the Model column. Click the switch to access its settings.



2. Click the Ports tab.





3. Click **Actions** for the port you want to configure.



4. Select the appropriate PoE setting: Off or PoE+. Then click Apply.
