- 1.App Download**
- IOS version: Type in “Wifi-Space” to search and download from App Store, or scan below QR Code to download.
- Android version: Type in “Wifi-Space” to search and download from Google Play or other stores, or scan below QR Code to download.



- 2.How to use on mobile phone**
- A、 Long press power button 2 seconds to turn on Wifi (need 30 sec to start wifi),green led flash;
- B、 Go to mobile’s Setting→Wifi→Search for “Wifi-Space” ;
- C、 No Password required for the first connection;
- D、 When connected then open the App to operate & use.

- 3.How to use on PC**
- Connect the device to PC with the USB cable, it can be used as normal USB Flash Drive.(When connected to PC, Wifi connection /access will not be available)

- 4.Charge the device**
- When only 1 White LED is flashing, device is low power. Please use the Micro USB cable to charge the device.4 White LED on means fully charged , about 3 hours

- 5.App Operation Guidance**

- New versions of App will be published for better performance. Below guidance for reference only.

- 1.Video: View, Play, Copy, Transfer video files in device
- 2.Photo: View, Play, Copy, Transfer photo files in device
- 3.Audio: View, Play, Copy, Transfer audio files in device
- 4.Documents: View, Play, Copy, Transfer common documents in device, PDF, World, Excel etc.
- 5.All: View, Play, Copy, Transfer all files in device

- 6.Wifi network connection: Wifi relay, enable mobile surf the internet over Wifi Router
  - a. Click WiFi butter on mian UI to connect
  - b. Refresh available networks, click the network to connect
  - c. Reboot device, Wifi indicator will flash rapidly. Go to mobile’s Setting---Wifi---reconnect to device’s Wifi
- 4). Enter Wifi relay to check connection status
- 7.Set Wifi device name and password
  - a. Enter Setting---Device management---Change device name and password---Confirm changes---Device reboot---Reconnect
  - b. In case forget password, when Wifi is on, long press power button for 10 seconds to reboot the device to reset, all 5 LED on for 3 seconds to indicate.

- Q: What formats of documents supported?
- A: Video: wmv, flv, 3gp, mp4, mov, avi, mkv, mpg, rmvb etc.
- Audio: m4a, wav, mp3
- Photo: ipg, bmp, jpeg, png, gif
- Documents: txt, pdf, xls, xlsx, pptx, doc, docx

- Q: Are the movie & video files from Youku, iQiyi, Youtube possible to be stored inside device?
- A.Due to system limitation, you can not store these files directly to external storage device. Need to copy the exsiting files from PC to device to watch.

- Q.What files can not be viewed/copied/transferred in App?
- A.For iOS users, due to system limitation, files received through QQ can not be viewed/copied/transferred in App; Third party music player’s audio files can not be viewed/copied/transferred in App.

- Q. Where are the photo files copied/transferred from device?
- A.For iOS users, view these photos from Album or check under App’s Photo.
