WS-SHWIFI-04C 433 RF 模組專為智慧家居而設計,以降到整個系統的成本為目的。由於 WIFI 的成本較高,所以定向研發了 433 RF 模組。該模組自帶 MCU,能實現雙向通信、自組網、自我調整、資料自動轉發功能。

WS-SHWIFI-04C 433 RF module is designed for smart home, and the purpose is to reduce the cost of the system. As the cost of WIFI is higher, so we decided to development of the 433 RF module. The module comes with MCU, can achieve two-way communication, self-organizing network, self-adjustment, and automatic forwarding information.


This module is divided into host and slave, according to the internal procedure. This module is applied to the smart home, which can greatly reduce the cost of the control system. This module has 4 IO that can control the relays connection or disconnection and so on. The current required for the module is relatively small, and the maximum only 60mA. Thus, it simplifies the design of the power.


