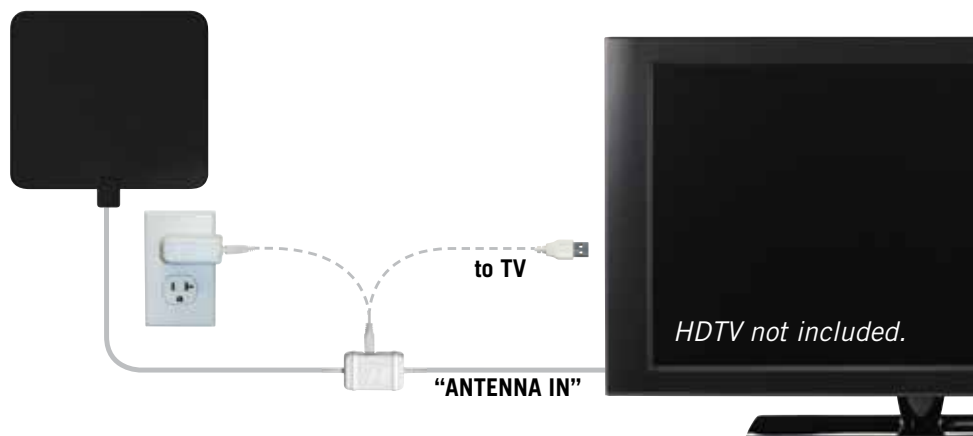

with antenna placement.



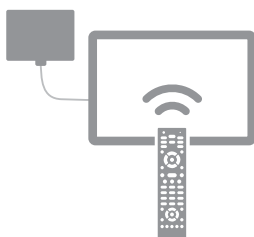
Follow the on-screen steps to

3) Scan.

Brand Strips, which can be placed on
any part of the antenna.

Select **Menu** then **Channel Search**.
