- Using your computer, Connect a USB cable to a USB outlet on your computer. Using the micro-USB connector, connect the other end of the USB cable to an "DC 5V" port on the speaker. Make sure the computer is on to begin charging the speaker.
- Connecting the speaker with Bluetooth:
- . Press and hold power button to turn ON the speaker LED Indicator will flash BLUE when in
- . Turn on the Bluetooth function on mobile device, Select "Blackwater Speaker" pairing name, LED will turn solid BLUE if successfully paired.
- Speaker will automatically pair if the mobile device has been paired before.
- Using the speaker:
- a. When receiving a phone call, the speaker will pause the current audio. Press the Play/Pause /Power /Phone button to answer the call. press this button again to end the call. Long press to reject the call.
- b. Short press (): play/pause the audio
- c. Short Press + : volume increase
- d. Long press + : next track
