




- 1. Surface Mat

## **Operation Instructions**

#### Setting up the DeskPad Pro™

- Unroll the DeskPad Pro<sup>™</sup> and lay flat on a desired surface.
- 2. Plug the 36" Type-C to USB-A Cable into the Type-C Port (Input).
- 3. Plug the USB-A end of the Cable into a compatible USB port (not inlcuded.)




## Operation Instructions cont'd

- 4. The Blue LED Power Indicator Light will illuminate.
- 5. The DeskPad Pro™ is ready to use.

#### NOTE:

Use any USB output from a laptop or computer.

When using a USB wall adapter, refer to the user manual to confirm the port's output does not exceed 9V/1.67A.



# Operation Instructions cont'd

#### Using the Wireless Charger


 With the DeskPad Pro<sup>™</sup> connected to power, place your compatible device on top of the Wireless Charging Pad.

#### NOTE:

The White LED Wireless Charging Indicator Light will illuminate when a successful connection is made and the device is charging.

If the White LED Wireless Charging Indicator Light is not illuminated or is flashing while trying to wirelessly charge, you should:

- · Check the Wireless Charging Pad for any foreign objects.
- Reposition the phone on the Wireless Charging Pad until a successful connection is made




## Operation Instructions cont'd

#### Cleaning the DeskPad Pro™

- Spills and liquids should be wiped off the DeskPad Pro™ right away.
- The DeskPad Pro<sup>™</sup> can be cleaned with a damp cloth.
- 3. To remove stains, add unsceented soap and water to a rag,
- To dry, wipe with a dry rag or paper towel.

#### NOTE:

Liquids should be kept away from the Wireless Charging Pad. It is recommended to keep beverages on the right side of the Surface Mat, opposite of the Wireless Charger. See below for diagram.





## **Exposure Statement**
