



OPERATING INSTRUCTIONS

BATTERY INFORMATION

The operation requires 4 "AA" 1.5V alkaline batteries for car and one 9V battery for remote control.

- Carefully remove items from package.
- Locate the battery compartment on the back of each item.
- Unscrew latch on bottom of car to release battery pack and replace batteries following the correct polarities.
- Replace the battery compartment door.
- Slide open the battery compartment door of the controller.
- Insert the 9V battery following the correct polarities.
- Replace the battery compartment door.





SAFETY PRECAUTIONS

- Do not operate during thunderstorms or rain. Avoid water, sand and snow when operating your car.
- Do not submerge car or controller in water.
- Never operate your car on the street or highway
- Adult supervision is recommended when operating this car.
 Remove all batteries when not in use to avoid accidental operation.
- Never operate your car in a confined or crowed area and
- do not use people or animals as obstacles. Do not run your car into furniture, objects or hard surfaces,
- as this will cause damage to both the objects and the car.
- Keep fingers, hair and loose clothing away from the tires, gears and motor while the car is switched to "ON"
- Do not leave car or transmitter near sources of heat or
- under direct sunlight for long periods of time.
- Do not leave car or transmitter outside overnight. Dampness is harmful to interior components.

BATTERY WARNING

- Do not mix old and new batteries.
- Do not mix alkaline, standard(carbon-zinc) or rechargeable (nickel-cadmium) batteries.
- Insert batteries using the correct polarity. Do not short-circuit the supply terminal.
- Remove batteries when not in use. Recycle or dispose of exhausted batteries according to federal, state or local laws. Do not dispose
- of batteries in a fire-they make leak or explode.
- Only use manufacture specified battery(ies), charger(s) and/or adapter, if applicable, specifies by the manufacturer.

 Always use, replace and recharge (if applicable) batteries under
- adult supervision.
- Non-rechargeable batteries are not to be recharged. **KEEP THIS PACKAGE FOR REFERENCE AS IT CONTAINS**
