

- Make sure you are wearing your HxM<sup>TM</sup> Smart device so that it is turned on. A green LED will flash every 3 seconds.
- Start your app and connect it to your HxM<sup>TM</sup> Smart device. The LED will flash twice every 3 seconds when connected to your Smartphone.
