### Zepp One (1) Year Limited Warranty

Zepp's warranty obligations for this hardware product are limited to the terms set forth below:

Zepp Holding Limited. ("Zepp") warrants this Zepp-branded hardware product against defects in materials and workmanship under normal use for a period of ONE (1) YEAR from the date of retail purchase by the original end-user purchaser ("Warranty Period"). If a hardware defect arises and a valid claim is received within the Warranty Period, at its option and to the extent permitted by law, Zepp will either (1) repair the hardware defect at no charge, using new or refurbished replacement parts, (2) exchange the product with a product that is new or which has been manufactured

from new or serviceable used parts and is at least functionally equivalent to the original product, or (3) refund the purchase price of the product. Zepp may request that you replace defective parts with new or refurbished user-installable parts that Zepp provides in fulfillment of its warranty obligation. A replacement product or part, including a user-installable part that has been installed in accordance with instructions provided by Zepp, assumes the remaining warranty of the original product or ninety (90) days from the date of replacement or repair, whichever provides longer coverage for you. When a product or part is exchanged, any replacement item becomes your property and the replaced item becomes Zepp's property. Parts provided by Zepp in fulfillment of its warranty obligation must be used in products for which warranty service is claimed. When a refund is given, the product for which the refund is provided must be returned to Zepp and becomes Zepp's property.

#### EXCLUSIONS AND LIMITATIONS

This Limited Warranty applies only to hardware products manufactured by or for Zepp that can be identified by the "Zepp" or "GolfSense" trademark, trade name, or logo affixed to them.
