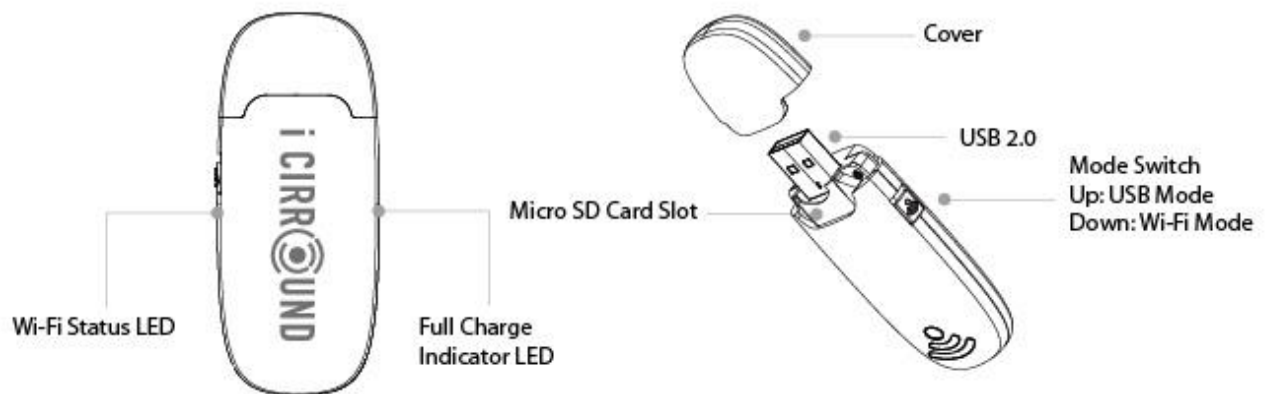

Note: Please remember to insert SD/SDHC memory card firstly

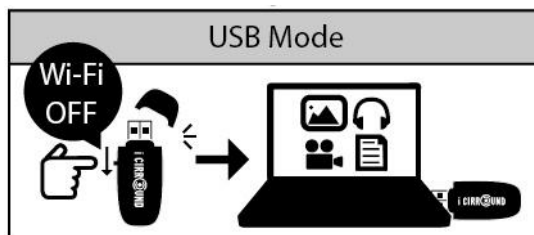
### A. Wi-Fi Mode
