

Working in sync with the Incipio® offGRID™ Smart App, the power bank uses Bluetooth® Smart technology to communicate with your device to read battery levels, forecast charge and discharge times, and location.

Press and hold  for 2 seconds to activate pairing mode and connect

**CHARGING YOUR DEVICE**

**TO START**

Plug in your device, press and hold  for 2 seconds to start charging

**TO STOP**

Press and hold  for 2 seconds or simply unplug cable to stop charging


