TWO (2) YEAR INTERNATIONAL WARRANTY

Your MICHAEL KORS watch is warranted by Michael Kors Watches* for a period two (2) years from the original date of purchase under the terms and conditions of this warranty. The Michael Kors warranty covers materials and manufacturing defects. A copy of the receipt or dealer stamp in the warranty booklet is required for proof of purchase.

During the warranty period the watch movement, hands and dial are the only components covered under this warranty. A covered component will be repaired or the watch will be replaced free of repair charges, if it proves to be defective in material or workmanship under normal use.

In case of replacement, Michael Kors cannot guarantee that you will receive the same model watch. If your model is not available, a watch of equal value and similar style will be provided. The warranty for the replacement watch ends two (2) years from the date the replacement watch is received.

THIS WARRANTY DOES NOT COVER:

- Any defects in materials and workmanship of battery, case, crystal, strap or bracelet.
- · Damage resulting from improper handling, lack of care, accidents, or normal wear and tear.
- Water damage unless marked water-resistant.

This warranty is void if the watch has been damaged by accident, negligence of persons other than authorized Michael Kors sales or services agents, unauthorized service, or other factors not due to defects in materials or workmanship.

WHAT IS COVERED AND FOR HOW LONG?

Fossil Group, Inc. ("Michael Kors") warrants that this Michael Kors product and accessories included in the packaging with the product (the "Product") are free from defects in material and workmanship under normal use for the period commencing upon the date of purchase and continuing for two years.

WHAT IS NOT COVERED?

Uninterrupted or Error-Free. Michael Kors does not warrant that the operation of the Product will be uninterrupted or error-free. Michael Kors is not responsible for damage arising from failure to follow instructions relating to the Product's use.

Normal Wear and Tear. Periodic maintenance, repair and replacement of parts due to normal wear and tear are excluded from coverage.

Case and Crystal (if applicable). Michael Kors does not warrant cases or crystals.

Bracelet. Michael Kors does not warrant bracelets or straps.

Batteries. Only rechargeable batteries whose fully charged capacity falls below 80% of their rated capacity and batteries that leak are covered by this Limited Warranty. Non-rechargeable batteries are not covered under this Limited Warranty.
